BIOGRAPHICAL NOTE

The Carlisle Indian Industrial School was founded by Lieutenant Richard Henry Pratt. In 1875, Pratt was responsible for transporting Native Americans identified as subversive to a prison in St. Augustine, Florida, where he eventually conceived the idea of a school. Approval was ultimately given for a school to be established at the deserted military barracks in Carlisle, Pennsylvania. In October 1879, the first students began arriving at the United States Training and Industrial School at Carlisle Barracks.

Pratt's plan for the Carlisle Indian School, which argued that Indian children were "blank slates" who could be civilized via contact with whites, ran counter to notions of inherent savagery which informed programs in play at similar institutions, such as Samuel Chapman Armstrong's Hampton Normal School for African Americans. By exposing Native American children to Euro-American culture through education, industrial training, and a unique "outing program" which placed individual students in the homes of white Christian families, Pratt hoped to assimilate his pupils into the greater culture of the United States. Over time, the school also became known for its nationally renowned sports teams, which produced athletes including Jim Thorpe and Lewis Tewanima, as well as for frequent public controversies over student behavior, substandard living conditions, ineffective teaching, and embezzlement.

Pratt operated the Carlisle Indian School as superintendent from 1879 to 1904, when he was forcibly retired due to political disagreements with high-ranking officials in the Bureau of Indian Affairs. The school operated for another 14 years under various different superintendents before finally closing in 1918 to make way for the Medical Field Service School of the U.S. Army. By that time, it is estimated that between 10,000 and 15,000 students attended the school over its 39-year history.

COLLECTION DESCRIPTION

These Carlisle Indian School Papers are housed in one document box and one oversized folder. These materials were purchased as a group from Robert Rowe in 2014; Rowe operated an auction business in Carlisle, PA for many years. The collection has been organized into four categories: Milton I. Zeigler Business Papers, Postcards, Ephemera, and Publications.

Milton I. Zeigler served as the industrial instructor for the shoe and harness department at the Carlisle Indian School from about 1901 to 1909. His business papers consist of the following: correspondence with multiple agents of the Department of the Interior, Bureau of Indian Affairs, and various mining and leather suppliers; vouchers for expenses incurred during various trips to Chicago on Bureau business; and standardized business forms. One oversized folder, listed at the end of the inventory, holds two of Ziegler's vouchers that are separately housed due to their size.

The Postcard section includes postcards arranged chronologically by date of mailing which are described according to the subject matter of the image. Cards of unknown senders and dates, as well as cards that were never mailed, appear at the end of this series.

The Ephemera section includes documents from three different years' commencement activities, arranged chronologically, followed by a number of half- and quarter- sheets with quotations on them, all of which were printed by the Carlisle Indian School Press.

The Publications section includes multiple publications from the Government Printing Office related to the operation of Carlisle and other Indian schools, two souvenir booklets printed about the Carlisle Indian School, and a copy of *Stiya: A Carlisle Indian Girl at Home*, written under the pseudonym Embe by Marianna Burgess, who served as the school matron and supervisor of the school's printing department in the late 19th century.
