BIOGRAPHICAL SKETCH

Jane Lee, a farmer from Etters, Pennsylvania, became active in various anti-nuclear groups such as Three Mile Island Alert following the accident at the Three Mile Island Nuclear Station on March 28, 1979. Since the accident she has done extensive research on effects of radiation on plants and animals, and she has served on the Environmental Quality Control Board in the area. Over the years she has dedicated a considerable amount of time and energy to the fight against the restart of Three Mile Island, and remains active to date through her work with Three Mile Island Alert.

COLLECTION DESCRIPTION

The Jane Lee Collection consists of various papers, court dockets, government documents, and newspaper clippings collected by Lee in the years following the accident at Three Mile Island. The collection is divided into 7 series: Personal Papers, General Business, Nuclear Regulatory Commission, Miscellaneous Organizations, Legal/Judicial Papers, Journal and Magazine Articles, and Newspaper Articles. Series 1 - Personal Papers contains Jane Lee's personal papers and correspondence that are unrelated to her work with any particular organization. Series 2 - General Business contains all of the papers that are not exclusively related to a particular organization in the collection. Series 3 - Nuclear Regulatory Commission contains mainly correspondence, government documents, and publications put out by the NRC concerning nuclear energy. Series 4 - Miscellaneous Organizations contains the papers of multiple organizations which have been organized together due to size, and can be found in alphabetical order. Series 5 - Legal/Judicial Papers contains documents relating to court cases that resulted from the accident at Three Mile Island. Finally, Series 6 - Journal and Magazine Articles and Series 7 - Newspaper Articles contain various printed items collected by Jane Lee. More detailed series descriptions appear before each series inventory.

COLLECTION INVENTORY

The Personal Papers series consists solely of the papers of Jane Lee that cannot be placed with a particular organization. This series is divided into two sub-series: Correspondence and General Papers. The Correspondence sub-series contains letters sent and received by Jane Lee, and are arranged in chronological order. SERIES 3 - NUCLEAR REGULATORY COMMISSION (NRC)

The Nuclear Regulatory Commission is an official United States government agency charged with promoting and controlling the nuclear energy plants within the United States. The NRC papers are divided into three sub-series: Correspondence, Printed Materials, and Reports. The Correspondence sub-series contains letters sent by the NRC, and are arranged in chronological order from 1979 to 1988. The sub-series also holds internal memoranda from the NRC arranged chronologically from 1979 to 1987. The Printed Materials sub-series contains copies of the NRC publication, *Federal Register*, IE Bulletins and Information Notices, and press releases, which are all arranged in chronological order within their category. Finally, the Reports sub-series contains a number of NUREG reports along with various other reports written by the NRC regarding nuclear activity. The NUREG reports are arranged chronologically with the remaining reports to follow in chronological order.
