BIOGRAPHICAL NOTE

Edward Shippen Burd was born in 1779, son of Edward Burd, who was an attorney from Reading, Pennsylvania. Edward Burd was appointed the prothonotary of the Pennsylvania Supreme Court in 1778 and was reappointed in 1791. In 1785 Edward Burd joined the Philosophical Society, a group founded for the promotion of useful knowledge, along with such prominent individuals as James Madison and Joseph Priestley. In 1800 Edward Burd was appointed the Clerk of the Supreme Court of Pennsylvania.

Edward Shippen Burd became an attorney like his father and settled in Philadelphia, PA. He married Eliza Howard Simms, a woman who would become well-known as a folk artist of watercolor scene paintings in the 1840's.

This collection reflects the fact that Edward Shippen Burd was a very wealthy and prominent lawyer. He was heavily involved in real estate as well as other business ventures such as the Philadelphia Arcade and the Philadelphia Ice Company. At the time of his death on September 17, 1848, the Edward Shippen Burd Estate was valued at more than \$560,000.

Edward Shippen Burd and his wife also pursued philanthropic interests, particularly through St. Stephen's Church in Philadelphia, PA. Eliza Howard Burd was clearly very active in the church and in the community as well. Evidence of her generosity includes a \$5000 bond to the Protestant Episcopal Hospital of Philadelphia and a bequest (Eliza Howard Burd died in 1860) of \$100,000 to St. Stephen's Church in order to open the Burd Orphan Asylum for daughters of Episcopal clergymen.

COLLECTION DESCRIPTION

The Edward Shippen Burd Collection is housed in one document box and two oversized folders and is organized into three basic categories: Correspondence, Legal and Financial Documents, and Portraits. For sake of clarity throughout the collection inventory, Edward Burd's name will be spelled out while Edward Shippen Burd will be presented as E. S. Burd. Samuel and Anna Moyerman donated this collection of papers to Dickinson College in 1966.

The Correspondence section of this collection is arranged alphabetically according to the author of each letter, and then chronologically. The bulk of the correspondence are letters written to or by Edward Shippen Burd and primarily deal with his various professional and business endeavors.

The Legal and Financial Documents section of this collection is arranged alphabetically according to whom the papers concern, and then chronologically. This section contains various documents such as land deeds, leases, receipts, and survey maps. The bulk of these papers revolve around the estates of Edward Shippen Burd and Eliza Howard Simms Burd. Other philanthropic and business concerns of Edward Shippen Burd reflected in these documents are papers relating to the Philadelphia Arcade, the Philadelphia Ice Company, and St. Stephen's Church in Philadelphia, PA.

The Portrait section of the collection includes one folder containing eight prints of a portrait of Edward Shippen Burd by an unknown artist. A print of a George Cadwalader portrait appears on the verso of the E. S. Burd images.

Two folders of oversized materials, designated OC 1999.10, contain various legal and financial documents of Edward Burd and Edward Shippen Burd, including deeds and indentures. The materials in these folders have been arranged chronologically.
