## **President Edel to Preside Over 186th Commencement**

WHEN he declares the 186th academic year closed at the end of the Commencement Exercises on Sunday afternoon, June 7, it will be the last time Dr. William W. Edel will preside at Commencement as the President of the College. Before then some additions to the three day program will brighten the Commencement scene.

The Honorable Hugh Scott, United States Senator from Pennsylvania will be the speaker at the Commencement Exercises in the Alumni Gymnasium. Nine will receive honorary degrees, ROTC graduates will receive their commissions and probably 215 seniors will be awarded their diplomas.

To alumni one of the high spots of these exercises will be the awarding of an honorary degree to Richard H. Mac-Andrews. "Mac" will receive the degree of Doctor of Physical Education.

The Rev. Dr. F. Lamont Henninger, '24, Superintendent of the Harrisburg District of the Central Pennsylvania Methodist Conference and Secretary of the Board of Trustees of the College, will preach at the Baccalaureate Services to be held on Sunday morning, June 7, in the new Dickinson College Chapel-Allison Methodist Church. At that service two musical compositions written especially for Dickinson College will be sung for the first time at the Baccalaureate Service. They are "The King's Highway," an anthem, and "Here is the Chapel," a chorale. The compositions were written by Lee H. Bristol, Jr., who will be awarded the degree of Doctor of Music.

Dr. Bristol is a prolific composer of anthems and other music, and the author of "Seed for a Song," the biography of Bishop Robert Nelson Spencer, '03.

### **Register In Old West**

Alumni returning for Commencement should register in Old West upon their arrival. Tickets will be available there for any events for which tickets are necessary.

Information concerning hotel, motel or tourist home reservations can be secured there.

The lyrics for the anthem are from a poem by Evelyn Atwater Cummins, great granddaughter of Jeremiah Atwater, third president of Dickinson College. The connection between the authoress and Dickinson College was not revealed until Mrs. Cummins learned from The Church Hymnal Corporation that permission had been asked to set her poem to music.

The chorale is the musical setting for the verse which is engraved on the wall in the chapel in Bosler Hall. The stanza is from a long poem by Sir Henry Newbolt. Dr. Bristol was inspired by the words while visiting the College last year, at the time of his presentation to the library of his original manuscript and interview recordings used in the preparation of his biography of Bishop Spencer.

Another new entry in this year's Commencement program is the listing of lectures in the Roscoe Bonisteel Planetarium on Friday and Saturday in the Tome Building with Professor Henry Yealey in charge.

Some will be interested in the annual flower show of the Carlisle Garden Club which will be held on Friday and Saturday, June 5 and 6, in Fellowship Hall of Allison Methodist Church. The theme of the show is "Say it with Roses." There will be 100 or more specimens of roses and about 60 floral arrangements. Admission is free and returning alumni are welcome to visit the show. Last year the Carlisle Garden Club saluted Dickinson College with its annual flower show. Mrs. A. Douglas Thompson, mother of Patricia, a sophomore, is the chairman.

The meetings of the Board of Trustees will be held on Thursday, June 4 to enable the trustees to be on the campus on Friday, which is Senior Day. The annual dinner meeting of the Alumni Council will be held that evening in Morgan Hall at 6 o'clock and the 50th Reunion class of 1909 will gather at the James Wilson Hotel at the same time.

The Class of 1909 will have the seat of honor on the platform at the Alumni Luncheon at noon on Saturday, June 6, which is Alumni Day. Reunion chairmen and committees of all the classes slated to foregather this year report good responses and it is believed that there will be a record breaking attendance at this year's Alumni Luncheon and Commencement.

## **Praise President Edel For His Accomplishments**

S EVERAL tributes to Dr. Edel and his accomplishments while the president of the College have come from many corners. Several alumni clubs have honored him at their spring meetings and the Baltimore Club paid special tribute to him as a native Baltimorean. The Baltimore alumni also presented him with a handsome silver bowl.

Several hundred faculty, students, alumni and trustees were present on May 8, for the inauguration of the Dickinson College Arts Award in honor of Dr. Edel. The first recipient of the Award was Robert Frost, dean of American poets, who was a guest at the dinner and addressed the evening convocation.

The Arts Award was established by gifts from members of the faculty and endowed by members of the Board of Trustees, as a tribute to Dr. Edel and his accomplishments during his 13 years as president of the College. The Award is in the form of a Wedgwood medallion struck from a sculpture created by Nancy Dryfoos, distinguished American sculptress. The striking of the medallion by the Wedgwood Potteries of England, especially for Dickinson College, is in itself a tribute to Dr. Edel who has had a close association with the Wedgwood family. Dr. Frost also received a check for one thousand dollars. The Arts

Award parallels the long-established Priestley Award for scientists.

The community of Carlisle also recognized President Edel at a testimonial dinner on May 18, at Allenberry, attended by 200 persons from Carlisle and neighboring communities. This was the second of two Community Recognition Dinners to be sponsored by the Chamber of Commerce for persons who have made a distinctive cultural contribution to the community. The first was given for Major General Max S. Johnson, former Commandant of the U. S. Army War College, when he retired from the service earlier this year.

Frank E. Masland, Jr., '18, a contemporary of President Edel at Dickinson College, gave the main address at the Community Recognition Dinner and paid highest tribute to President Edel, using the individual letters of the word "Service" for his outline. Dr. Masland referred to President Edel as an outstanding salesman and scholar, executive and enuissary, researcher and religious leader, veteran, internationalist, counselor and educator.

In addition to the tribute by Dr. Masland, written words of praise were received from such notables as Arthur S. Flemming, Lewis Strauss, Herbert Brownell, Douglas McKay, John O. Gross and many others.

In making the presentation, Mr. Respess, who is secretary of the General Alumni Association, said:



Gilbert Malcolm spoke briefly and George Shuman, Jr., showed some colored slides of the campus to wind up the program.

## Annual Giving Program Nearing High Goals

THE Annual Giving Program is well on its way toward accomplishing its two-fold objective for 1959: (1) receipt of the one millionth dollar in annual giving since 1936 and (2) accomplishment of a goal of \$200,000 and 2,500 contributors this year.

The receipt of the one millionth dollar makes this a milestone year in annual giving and preparations are being made for suitable recognition of the occasion at Commencement. The name of the contributor of the one millionth dollar will be announced at that time and a scroll will be prepared containing the name of the contributor and the one millionth annual giving dollar, and highlights in the history of the Annual Giving Program. Later a bronze tablet will be prepared to commemorate the inclusion of the Annual Giving Program among the major gifts of the College. The tablet will be installed in the Hall of the Presidents in Old West.

Win Cook, '32, serving his first term as chairman of the alumni phase of the Annual Giving Program, has traveled several thousand miles to speak before alumni clubs. A successful salesman, Win, as president of Vita Craft Pennsylvania Sales, Inc., has acquired a worldwide reputation for salesmanship and has served as an emissary from the United States to teach American sales techniques abroad. He has applied some of these techniques to the task of winning new support for Dickinson College Annual Giving Program. If the goal of \$200,000 and 2,500 contributors is reached, the Annual Giving Program will have established its fifth consecutive record. The tradition of setting records in annual giving each year, was started in 1954 by John Milton Davidson, '33, first general chairman.

Last year, when Davidson turned the reins over to Cook, the Annual Giving Program had reached a total of \$167,-665.41 from 1,764 contributors. The total amount of annual giving since 1936 was nearly \$844,000, just \$156,000 short of the one millionth dollar.

When the College receives its one millionth dollar sometime before June 1, it will be a dramatic fulfillment of Professor B. O. McIntire's prophesy which he made at the launching of the Library Guild in 1903. He said:

"... contributions of moderate size are within the means of many alumni and in the aggregate consistently reach surprising goals."

### **Receives Fulbright Grant**

Richard M. Keer, '49, a member of the Livingston, N. J., high school language department since 1956, has been awarded a Fulbright grant to attend an eight-week summer seminar in Germany.

## Nine to Receive Honorary Degrees June 7

FOUR of the nine honorary degrees which will be conferred at the 186th Commencement Exercises in the Alumni Gymnasium on Sunday afternoon, June 7, will be upon alumni and another on Richard H. MacAndrews, who to many is "the ivy on the wall." Another member of the Dickinson family, Dean Morris L. Shafer, of the law school, will receive the degree of Doctor of Laws. That degree will also be awarded to the Honorable Hugh Scott, United States Senator from Pennsylvania, who will be the Commencement speaker.

Hugh B. Woodward, '08, will receive a Doctor of Laws degree and Dr. F. LaMont Henninger, '24, the degree of Doctor of Sacred Theology; James R. Shepley, '39, the degree of Doctor of Letters and Dr. John W. McConnell, '29, the degree of Doctor of Science.

Nicholas B. Wainwright, editor and author, will be awarded the degree of Doctor of Letters and Lee Hastings Bristol, composer and librettist, the degree of Doctor of Music.

### Hugh Scott

After 16 years as U. S. Representative from the Sixth District of Pennsylvania, Hugh Scott was elected to the United States Senate, November, 1958. He is a member of the Committee on Interstate and Foreign Commerce and the Committee on Public Works. A lawyer by profession, he was Assistant District Attorney of Philadelphia 1926-1941, and is General Counsel of the Republican National Committee. He was National Chairman of the Republican Party, 1948-49.

He is the author of "Scott on Bailments" published in 1931, "How to Go Into Politics," (1949) and numerous articles in national magazines.

He saw service in the Merchant Marine and Navy in World Wars I and II. Entering the Naval Reserve in World War II as a Lieutenant, he was discharged as a Commander after service with the North Atlantic Patrol, occupation of Iceland, duty in the Pacific area, including occupation of Japan and at Naktong in the Korean War.

Educated at the University of Pennsylvania and Randolph-Macon College, he received an LL.B. from the University of Virginia in 1922. In 1955, he was awarded two honorary degrees, an LL.D. from Randolph-Macon and an L.H.D. from LaSalle College.

A member of Phi Beta Kappa, Alpha Chi Rho and Tau Kappa Alpha, Mr. Scott is active in professional, veterans and fraternal organizations. His clubs include Caveat, Philadelphia Cricket, the Union League, Germantown Lions, and Army and Navy, of Washington. He is an Episcopalian.

His wife is the former Marian Huntington Chase, an alumna of Germantown Friends School. They have a daughter, Marian Scott Concannon and a granddaughter, Anne Concannon.

### Morris L. Shafer

Dr. Morris L. Shafer, scholar, educator and lawyer, began his work as Dean of the Dickinson School of Law in September 1956.

A native of Pennsylvania, he graduated from Muhlenberg College in 1925 and received an A.M. in Economics from Lafayette in 1929. He did graduate work in history at Lehigh University and in economics at the University of Pennsylvania before receiving his Ph.D. degree from New York University in 1935. Beginning in 1934, he taught economics in the School of Education of New York University in both undergraduate and graduate levels. He was also administrative assistant of the Division of General Education there.

Later Dr. Shafer entered the University of Pennsylvania Law School and received his LL.B. degree in 1947. He practiced law in Allentown until his election as Dean of the Law School.

He is a Lutheran and a member of the Livingstone Club. He and Mrs. Shafer have no children.

### Richard H. MacAndrews

Richard H. MacAndrews is the beloved "Mac" of Dickinson athletics. He retired in 1949 with the rank of associate professor emeritus of physical education but never left the College he loves with the devotion of the most loyal alumnus. Each day finds him in his office in the Gymnasium or strolling about the campus, always in the company of admiring students. He has a suite at Conway Hall.

Mac, a native of Luzerne, Pa., was playing professional baseball back in 1911 when Sylvester "Si" Pauxtis, then football coach, brought him to the College as team trainer. Mac also helped with athletics at Conway Hall until that prep school closed in 1917, after which he gave all of his time to Dickinson teams. He became baseball coach in 1918 and basketball coach in 1919 and held both positions until 1947 when appointed advisory coach. He became a phsyical education assistant in 1920 and later helped to develop the College's extensive intramural program.

It was as basketball coach that Mac is best known beyond the campus. He had many outstanding teams, particularly in the '20s when Dickinson was playing such teams as Penn, C. C. N. Y., Princeton, Temple and others. His 1925-26 and 1930-31 teams lost only two games and may have been his best. His durability is indicated by the fact that the 1947 team, his last, posted a 15-3 won and lost record.

He is an honorary member of Ravens Claw Society.

### Hugh B. Woodward

Following his graduation from the College with Phi Beta Kappa honors in 1908, Hugh B. Woodward entered the Dickinson School of Law and received his LL.B. in 1910 and an A.M. from the College. He returned to his native Clearfield, Pa., to practice law until 1912 when he moved to Greeley, Colo., and three years later to Clayton, N. M. His home is now in Albuquerque, where he lives with his wife, the former Helen E. Kisner, also '08.

He has had a distinguished career before the bars of State, Federal, Circuit and the U. S. Supreme Courts. He was District Attorney of the 8th N. M. District, 1920-24; United States District Attorney of New Mexico, 1929-29; Special Assistant to the U. S. Attorney General, 1942-46 and Lieutenant Governor of New Mexico, 1928-29.

Interested in education he was president of the Board of Education, Clayton, N. M., 1916-1920 and a member of the Board of Regents of the University of New Mexico, 1935-38.

Devoted to wildlife, he is a director and a member of the executive committee of the National Wildlife Federation and since 1957 has been president of the National Wildlife Federation Endowment, Inc.

In business, he is president of the New Mexico Credit Corporation and president of the Southwestern Construction Company.

Active in politics, he was chairman of the Republican State Convention of New Mexico in 1922 and again in 1928. He was also chairman of the N. M. Republican State Central Committee, 1922-23. A Presbyterian, he is a Mason and a member of Sigma Alpha Epsilon and Delta Chi.

### F. LaMont Henninger

Since 1953, Dr. F. LaMont Henninger has been Superintendent of the Harrisburg District of the Central Pennsylvania Methodist Conference and a Trustee of Dickinson College since 1954. A year ago, he was elected Secretary of the Board. He is also a Trustee of Drew University and of Lycoming College, the Wesley Foundation, the Methodist Training Camp, the Pennsylvania Temperance League, the Central Pennsylvania Conference and the Methodist Home for Children, Mechanicsburg, Pa. He is also President of the Board of Directors of the Harrisburg Methodist Union and a director of the Pennsylvania Council of Churches.

Dr. Henninger has filled a number of important church offices, and important pulpits in his conference. From July 1946 to June 1949 he was Executive Minister in Rochester, N. Y. He is in his second term as a District Superintendent, having had that office in the

Sunbury District, 1939-45. He served as a member of the Northeastern Jurisdictional Conference in 1940, 1944, 1952 and 1956 and as a member of General Conference in 1952 and 1956.

From 1944 to 1948, he was chairman of the Northeastern Jurisdictional Board of Evangelism and in the same years a member of the General Board of Evangelism. Four years earlier, he was Chairman of the Northeastern Jurisdictional Board of Missions.

Born in Williamsport he graduated from the College in 1924 and received his B.D. from Drew Theological Seminary in 1926, the degree of Master of Theology from Drew University in 1929 and the Doctor of Theology degree in 1930.

His wife is the former Harriet S. Stoner. Their daughter, Carolyn, graduated from the College in 1947. They have a son, William McDowell Henninger.

### James R. Shepley

James R. Shepley, journalist, has been chief correspondent for *Time-Life* United States and Canadian New Service since 1957 at the New York headquarters.

A native of Harrisburg, he began his career on the *Patriot*, of which his father,

C. Laurence Shepley, was then the managing editor and Dean Hoffman, '02, was the editor. He then became a correspondent for the *Pittsburgh Press* and Pennsylvania legislative correspondent for the United Press Association, and its Washington correspondent in 1940.

He became associated with *Time* magazine in 1942 and was its foreign policy correspondent from 1946 to 1948. During World War II, he was war correspondent for *Time* and *Life* magazines in the China-Burma-India Theatre, the South Pacific and also the E.T.O. Two years after he returned to the Washington bureau, he became the youngest bureau chief when at 30 he was named chief Washington correspondent and serving nine years he had the longest tenure of any of his predecessors.

In 1945, he was U. S. staff officer at the Potsdam Conference and 1945-46 he served as Captain, General Staff Corps, attached Chief of Staff, General George C. Marshall, with whom he collaborated on Marshall's official report. He has been a major in the U. S. Air Force Reserve since 1950. He was awarded a War Department Commendation and a Letter of Commendation.

He is the co-author of the startling volume "Hydrogen Bomb" and is a

member of the National Press Club and the Army Navy Club. His home is Brightwaters, N. Y., with his wife Yvonne Hudson Shepley and their children.

### John W. McConnell

Dr. John W. McConnell has been Dean of the Graduate School of Cornell University since November, 1955, and has been a member of the faculty there since 1946.

The next two years he was assistant professor of economics and sociology at American University until 1939 when he became professor of sociology at New York University, where he taught until going to Cornell as Professor of Industrial and Labor Relations.

He is the author of several books and is a frequent contributor to professional journals, while serving on the editorial board of the *Industrial and Labor Relations Review*. Among his books are *Evolution of Social Classes, Basic Teach*-

Nicholas B. He is co-author of the History of the

In 1953 his History of the Philadelphia National Bank: A Century and a Half of Philadelphia Banking was published. In 1958 the Historical Society published his Philadelphia in the Romantic Age of Lithography. In May, 1959, the Institute of Early American History and Culture is publishing through the University of North Carolina Press Mr. Wainwright's biography George Croghan, Wilderness Diplomat. In addition to these five books, Mr. Wainwright has contributed a large number of articles to historical quarterlies, as well as book reviews. His contributions are to be found in the publications of the Historical Society of Pennsylvania, the New York Historical Society, the American Philosophical Society, the Montgomery County Historical Society, and in Pennsylvania History, William and Mary Quarterly, and the Mississippi Valley Historical Review.

A member of a Philadelphia family, he was born on July 12, 1914, and is a graduate of St. George's School, Newport, R. I. He graduated from Princeton in 1936 with honors in history and joined the staff of the Historical Society of Pennsylvania in 1939. 

# A New Bookplate For The Library Funds

A NEW bookplate, reproduced here, has been designed for books purchased from the general and special funds of the Library Guild. In the case of the special funds, the donor's or the memorial name is printed under the design. Each year these plates, in numbers appropriate to the size of each fund, will be assigned for use.

The Library Guild was founded in 1903 for the purpose of providing a permanent endowment for the purchase of books. The Library had then a relatively new building, but the best part of its book collection was still the union of the old student society libraries. Through the next twenty years, campaigning regularly for support, the Guild raised an endowment of \$36,383.00. Since that time, twenty-two other funds have been added. The smallest is \$50.00 and the largest is John M. Rhey's bequest of \$17,410.00. Of the memorial funds, one appropriately honors Bradford O. Mc-Intire, founder of the Guild, and another Paul Herbert Doney, his successor in the Thomas Beaver Chair and an equally warm supporter of the Guild.

In 1956, Dr. Roscoe O. Bonisteel followed his gift of first editions and manuscripts of John Drinkwater with his gift of the Bonisteel Fund for the purchase of books and manuscripts in the field of Literature. While most of the funds support the general needs of the Library, the Paul Herbert Doney Memorial is also assigned to Literature, the William B. Greenlee Fund to History, and the Waldron Phoenix Belknap, Jr., Memorial, to works in the Humanities. The new and still growing fund in memory of Dr. Vuilleumier is, of course, being used entirely for the acquisition of books in Chemistry. In this case, over half of the sum contributed so far has been expended at once, with a view to bringing the collection in Chemistry at once to a top level of excellence. It is to be hoped that the remainder, with the still-accruing gifts of students and colleagues, will



provide an endowment sufficient to keep it so.

## New Provost Is Named For Teachers College

THE appointment of Professor Max R. Brunstetter, '22, as Provost of Teachers College, Columbia University, effective July 1 was announced on April 24 by Dr. Hollis L. Caswell, president of the college. He had been serving as managing editor of the Bureau of Publications at the college since 1936. During that time he also served as an editor of the Teachers College Record.

After serving as associate professor of Education in Teachers College from 1946, he was promoted to the rank of professor of Education in 1952.

Born in Delano, Pa., he graduated from the Williamsport High School. Upon his graduation from the college in 1922, he taught a year at Bordentown, N. J. and then for five years he was principal of schools in Millville, N. J. He left the teaching field in 1930 for a six year stint with a concern producing talking pictures for schools. He is the author of a number of booklets and brochures on Business Management in School Systems of different sizes and also of programs for the Utilization of Audio-Visual Teaching Aids and the Use of Educational Sound Films. He has written an Introduction to French Pronunciation and Diction brochure and another for Spanish pronunciation.

### Writes On Church Music

Dr. J. Murray Barbour, '18, has an article included in the first issue of *Criticism*, a new quarterly for literature and arts, published by Wayne State University.

# Dean Hitchler Dies After a Year's Illness

**D**<sup>R.</sup> WALTER HARRISON HITCH-LER, Dean Emeritus of the Dickinson School of Law, died on February 5, after about a year's illness, two weeks before his 76th birthday.

Dean Hitchler had the longest period of service of any individual of what is now known as the Board of Athletic Control. In his earlier days, he was the Law School's representative on the joint association of the College and the law school on what was then called the Athletic Committee.

Many will remember him as a stellar player on the tennis courts, a graceful first baseman and an outstanding football official. As a confidant of Coach Richard MacAndrews, he aided in the development of many basketball and baseball teams, while football and tennis coaches sought his advice. He was the first tennis coach of the College and served in that capacity for 20 years, 1915 to 1935.

During World War I, he commanded the Dickinson College Reserve Officers Training Corps Unit from 1918 until 1919. With the outbreak of war, he went to Fort Niagara where he was commissioned a second lieutenant and was later promoted to the rank of captain.

He joined the faculty of the law school in 1906, resumed teaching after World War I and continued until 1930, when he became Dean of the school succeeding the late Dr. William Trickett. Two years later Dickinson College conferred upon him the honorary degree of Doctor of Civil Law. He was also awarded the degree of Doctor of Laws by St. Francis College and he held honorary degrees from Muhlenberg and from Albright.

He retired as Dean of the law school in June, 1954, after having served the school 48 years, 24 of them as a teacher. When he was elected Dean Emeritus, the Board of Trustees of the Law School established the Walter Harrison Hitchler

Scholarship Fund and his portrait was presented to the school.

Twice during his career, Dean Hitchler held important posts away from the campus, while continuing his work at the law School. In 1941, he was chairman of the Alien Enemy Hearing Board of the United States Department of Justice and from 1939 to 1940, he was chairman of the Pennsylvania Liquor Control Board. He also gained recognition as the editor of Statutory Law of Pennsylvania, 1919 to 1922.

Born in Plymouth, Pa., he received his early education there and graduated from the University of Virginia School of Law in 1905. After a year with the Michie Publishing Co. in Charlottesville, Va., he became a member of the law school faculty in 1906.

He was a member of St. John's Episcopal Church, Carlisle, where funeral services were held. He was a past president and active member of the Carlisle Rotary Club and prominent in community affairs, having served as director of the Carlisle Community Chest. He was a member of the American and Pennsylvania Bar Associations, the Ravens Society of the University of Virginia, the American Law Institute and the Masonic fraternity.

By the terms of his will, the bulk of his estate was bequeathed to the law school creating an endowment for the maintenance of the Sadler Curtilage, where he made his home, and for scholarship funds for needy students.

He is survived by a brother-in-law, Robert Johnson, of Wilkes-Barre, Pa. He never married.

### Seeks School Solution

Judge Herbert G. Cochran, '03, is deeply involved in the Virginia Public School crisis. He is a vice president of the Virginia Committee for Public Schools and also a member of the Advisory Board to the Norfolk Committee for Public Schools.

As a member of these groups, he is in communications and conferences with the Governor of Virginia and the Commission on Public Schools, which has been appointed to find a formulative plan and program for the solution of the school crisis in that state.

He is also taking an active part in the American Association for the United Nations and in the Norfolk Chapter of that Association. He was a delegate from the Norfolk Chapter to the first Biennial Convention of the Association, in New York City last November.

### Writing NAACP History

Prof. Flint Kellogg, of the history department of the College, is at work on a history of the National Association for the Advancement of Colored People under a grant from the Fund for the Republic. NAACP officers have referred to him as the foremost authority on matters dealing with the origin and growth of the movement. The February issue of *The Nation* carried an article by Prof. Kellogg on the role of Oswald Villard in the founding of the organization 50 years ago.

### Two New Honors

Two new honors will come to Frank E. Masland, Jr., '18, vice president of the Board of Trustees of the College, in June.

He has been elected to one of the top civilian positions in the Federal Government in being chosen Chairman of the Advisory Board of the National Parks, Historic Sites, Buildings and Monuments of the Department of Interior for a term to begin on June 1. He was first named to the Board in 1956 and is one of its most active members.

On June 7, he will deliver the Commencement address at Lebanon Valley College and will be awarded the honorary degree of Doctor of Laws by that institution. A year ago, he received that degree from Lycoming College.

### **Receives** Lutheran Award

The Rev. Francis E. Reinberger, '40, professor of practical theology at Lutheran Theological Seminary. Gettysburg, has been awarded a Lutheran Brotherhood Faculty Fellowship for graduate study. He plans to continue advanced work at Union Theological Seminary in New York.

His award was recommended by the National Lutheran Educational Conference, and he is among 17 Lutheran educators and pastors who are receiving Faculty Fellowship grants.

Instituted last year, Lutheran Brotherhood Faculty Fellowships are designed to promote and encourage advanced study by members of Lutheran college and seminary faculties. In addition to these awards, Lutheran Brotherhood also makes scholarships available to students at Lutheran educational institutions in the United States and Canada.

A graduate of the Seminary at Gettysburg, he received his Master's degree in 1957 from Johns Hopkins University. Before joining the Gettysburg faculty he was a pastor for nine years and an instructor at Hood and Messiah colleges.

## Mentioned For Governorship of Illinois in 1960

SAMUEL W. WITWER, JR., '30, is named as a possible candidate for Governor of Illinois in 1960 in a story headed "GOP's Governor 'Sleeper' for 1960" under the by-line of John Dreiske published in the *Chicago Sun-Times* on April 29. He is a Trustee of the College.

That article in full is as follows:

Influential Republicans who want very much to win the Illinois governship in 1960 and feel Gov. Stratton can't do it, may be grooming a "sleeper." Conceivably, if the governor could have his face saved by being given some other course he could follow with honor, he, too, could support this "sleeper."

The candidate the professional politicians of the Republican party think they see "coming up on the outside" is a 50-year-old Loop attorney, Samuel W. Witwer, who is a Riverside resident. Witwer is not a professional politician but he has been experiencing a solid, steady buildup as an active amateur concerned with vital issues.

Witwer has a long record of identification with the hard-fought and finally successful "Blue Ballot" constitutional amendment. This removed an old automatic road block of all intelligent amendments to the ancient Illinois constitution.

He has been actively in the lead of Illinois court reform which came so close to victory at the 1958 elections. Many questionably "void" ballots helped defeat this last effort. In both these causes, the Witwer name was given intensive, statewide circulation.

The unquestioned public service contributed by Witwer in these endeavors has stilled possible suspicions in the minds of some cynics in the business of politics that his work in this reform program might have been dedicated to the goal of the 1960 governorship.

Such speculation by the cynics seems immaterial. Because there he is, ready to be selected by the Republican party of

Illinois should its leaders agree that such a move is necessary to hold control of the executive mansion next year.

Currently, Witwer is Illinois state chairman for the United Service Organization which is conducting a drive for funds to finance "home-away-fromhome" hospitality to servicemen. The USO has unquestioned merit. Witwer is the sort of conscientious worker that helps guarantee the success of these worthy fund-raising campaigns.

We have been watching Witwer's career develop for some years now. It seems to be coming to a head.

There is widespread feeling in the Republican party that Gov. Stratton would be a weak candidate for re-election to a third term, principally through no fault of his own . . . namely, the Hodge scandal. Personally, I think Stratton's "weakness" is largely fictional.

He has always been a political powerhouse. There is no great amount of evidence that the Hodge scandal has been more than a temporary handicap to Stratton.

But the Witwer thing is worth watching anyway.

# Southern Florida Club Meets In Miami

WITH 37 present the annual dinner of the Southern Florida Club was held on February 24 at Old Scandia, Opa Locka, Fla.

These are full of interesting material. Dr. Cooper's discussion of explosives refers to duPont Powder Works and superior quality of duPont powder. Dr. Shadinger also presented copies of Cooper's "Introductory Lecture," delivered at Dickinson College in 1811, and his "Practical Treatise on Dyeing," published in Philadelphia in 1815. These gifts were accompanied by a group of five early chemistry text books, ranging in dates from 1822 to 1841.

Accolades were given to The Rev. Dr. George H. Bucher, who graduated from the college in 1895, and also to Mrs. Mary Ziegler, the widow of Geoge Zeigler of the Class of 1896, and sister of Dr. Bucher, both of whom were present. He has sent to the College library New Zealand Activities in the Antarctic, a government publication giving a succinct account of New Zealand's part in the expedition, and with it the more specialized report on tractor operation, written by Sir Edmund Hilliary and J. G. Bates, and published by the government for the Ross Sea Committee.

Mr. Helm was with the expedition in its first year, as Liaison and Postal Officer. He must share in full measure the satisfactions of all those associated with him. The Antarctic Continent, a region of high mountains the size of Europe and the United States combined, has for the first time been traversed, bringing to the world both an inspiring adventure and a vast accumulation of new scientific knowledge.

### Help Build A College

June 6 will see cornerstones laid for two buildings at Wesley College, Dover, Del. A new classroom building with little theatre and heating plant will be ready for use this summer, and a woman's dormitory will be completed by the beginning of the fall term. Construction of a dormitory for men will begin this spring and be ready for use next year. These are three of nine new buildings to be erected as part of a \$4,000,000 development program to make Wesley a first rate two-year college with 500 full time students. The campus plan prepared by Larson and Larson has been acclaimed as a "work of art."

Recognizing that buildings are only a part of the needs of a sound program of Christian higher education, the Board of Trustees has launched into several other phases as well. The charter has been completely revised—tying the school closely with the Methodist Church. (Wesley is the only Junior College related to the Methodist Church in the Washington Area.) A new faculty salary scale has been adopted which will be above the mean for NE U. S. A. The first retirement plan has been put in operation. The entire acadamic program has been reviewed.

This may be of special interest since much of the leadership for the program comes from Dickinsonians—Dr. J. Paul Slaybaugh, '21, President of the College; The Rev. Howell O. Wilkins, '44, pastor of Hillcrest Memorial Methodist Church

and chairman of the Board of Trustees of the college; Dr. John N. Bunting, '40, pastor of Newark Methodist Church and vice chairman of the Board of Trustees; and Bishop G. Bromley Oxnam is a member of the Board of both institutions.

### "The Sin Of Omission"

Dr. Dayton E. McClain, '06, is the author of *The Sin of Omission*, a 78paged book published recently by Dorrance & Company, Inc., of Philadelphia. Since 1939, he has been Vice President of The American University, Washington, D. C.

There is an interesting Preface to the book prepared by Dr. Samuel Engle Burr, Ir., Chairman of the Department of Education, The American University, In part he writes "Dr. McClain has chosen to emphasize a phase of Christianity which too frequently is overlooked or forgotten. He writes about 'The Sin of Omission.' In other words, he seeks to emphasize the fact that Christianity is a positive religion, that it is an active force, and that it is effective in the lives of human beings." Further on he writes "The good things men might do, but fail to do, make up another category of sins-a category much more important than it commonly is considered to be. Every sin of omission represents a worthy act or a good deed that did not come into being."

The jacket correctly says that Dr. Mc-Clain presents an extended sermon—one with great power and effectiveness.

Following his graduation with Phi Beta Kappa honors in 1906, Dr. McClain was ordained in the Methodist Church and served five pastorates in Maine and his native Maryland. For more than thirty years he has been engaged in fund raising for religious and education activities. He played a leading part in 1921-22 when the College and Pennington Seminary held a joint campaign for \$1,200,000, which was known as the Dickinson-Pennington Movement.

### Norman Twain: Broadway Producer

NORMAN TWAIN, '52, has reached success as a Broadway Play Producer and received many testimonies of approval from The *New York Times* to *Variety*. His future seems assured.

Three years spent at Dickinson where he majored in Political Science have come to be a sort of dream to him. Indeed life was then in many ways a dreamworld. Here he was a member of Phi Epsilon Pi. Faced with realities he left Carlisle to find a future he did not contemplate.

After graduating two years later from Columbia College with an A.B. degree, Norman served in the Army. On leaving the service he studied and acted at the Cleveland Playhouse, becoming Staff Director. Summers he devoted to playing stock at The Totem Pole, near Hagerstown, and at Holyoke, Massachusetts. He has appeared in 12 movies, 75 TV shows, and a total of 40 different plays.

His acting career was set aside for producing, when in January 1958, associated with the York Theater in New York, Twain's first production was Tennessee William's Garden District. This autumn as co-producer he presented Maxwell Anderson's Golden Six. Previous to its opening Twain wrote an article for the New York Times outlining the problems involved in this production.

His debut as a Broadway Producer came in January 1959 when he brought back John Osborn's *Epitaph for George Dillon* which had died an unnatural theater death during the Newspaper Strike. Under Twain's enthusiastic leadership, each week saw increasing box office success, more numerous mentions of Twain himself in theatrical columns, and ceasing only when no theater could be contracted for to extend the engagement of *Epitaph*. That play in the meantime has been nominated for innumerable awards and this largely due to Twain's own state and encouragement of the play.

Norman Twain's plans go forward. In the next year half his time will be spent

in Hollywood, half in Manhattan. While owning production rights to many ventures, first on his schedule for next year's Broadway line-up is to be *And So, Farewell* to arrive before Christmas.

Dickinsonians of this period will also be interested to know that Sanders Epstein, Esq. also '52 (Fordham Law '58) is Twain's theatrical lawyer.

### Speaks At Washington College

Many leading historians were in the audience that heard Dr. Whitfield J. Bell, Jr., '35, deliver the annual George Washington convocation address at Washington College, Chestertown, Md., on February 21. He spoke on the subject "The Noble Chieftain and the Immortal Sage: Washington and Franklin."

# Former Exchange Student Writes First Book

THE Library has received from Christof Wegelin, '41, a copy of his recently published book, *The Image of Europe in Henry James*, inscribed "In grateful memory of generous hospitality, 1940-41." Dr. Wegelin, a native of Switzerland, was sent at that time as an exchange student.

In the following year, he took his master's degree at the University of North Carolina and, in 1947, his Ph.D. at Johns Hopkins.

He has been a member of the faculties of English at Johns Hopkins, Princeton and, since 1952, the University of Oregon. He was a Fulbright lecturer at the University of Göttingen, Germany, 1955-56.

In 1946, he was married to Caroline Locke, then a teacher of modern dance at Smith College. They have two children, Bettina and Jacob Andreas.

Dr. Wegelin is the author of a number of articles on American and comparative literature. The Image of Europe in Henry James, published by the Southern Methodist University Press, is his first book. It will hold a place of special interest in the studies of recent years on the American in Europe and on the mutual influences of American and European points of view. The author, himself a cosmopolitan figure, is in a position to appreciate both with equal insight and sympathy. The result is a work which both emphasizes the greatness of Henry James as an artist, and links him the more firmly, despite his long expatriation, to our native literature.

### **Develops** Glasses For Navy

A technical report was published in December by the National Bureau of Standards, U. S. Department of Commerce, "Glasses with High Refractive Indices and Dispersions" (STR 2271), describing work done by Dr. Edgar H. Hamilton, '25. It is another addition in his long list of published articles of his work in research.

A summary states "Glasses with high refractive indices and high dispersions have been developed by the National Bureau of Standards for the Navy. Suitable for use in periscopes and in aerial cameras—where weight can be an important factor—the glasses give the optical designer a wide selection of optical properties."

As a starting point for the study, use was made of the fact that glasses containing appreciable quantities of titanium oxide have high-refractive indices and dispersions, the report states. It then adds "The sodium titanium silicate system was investigated in detail by E. H. Hamilton and G. W. Cleek of the Bureau's glass laboratories, and found to produce glasses with the desired optical characteristics."

### More In Who's Who

There are at least 60 Dickinsonians, exclusive of honorary alumni, in *Who's Who*. It has been learned that 17 names were omitted from the February number of THE DICKINSON ALUMNUS,

In some cases, names are listed in the current Who's Who, though biographies appeared in earlier editions. Some of the names appeared in issues of Who's Who not long after graduation from Dickinson and have been in succeeding volumes of the book over many years. This is true for example in the case of Dr. Edmund S. Soper, '98, former President of Ohio Wesleyan University.

The Class of 1906 and 1930 lead other classes with four names each, while 1908, 1910, 1915 and 1924 each have three. The 1906 men are Lynn Harold Harris, Dayton E. McClain, Myrl S. Myers and Harry M. Scarborough. The 1930 men are Tobias H. Dunkelberger and his college roommate, Vincent Mc-Crossen, Alson J. Smith and Samuel W. Witwer, Jr.

It is interesting that with but nine exceptions every class from 1908 to 1939 has a living biographee in Volume 28 of *Who's Who*.

It may be there are more than the 60 reported in the two issues of THE DICK-INSON ALUMNUS. Anyone in Who's Who, whose name has not appeared in either of these accounts, is urged to write to the editor of THE DICKINSON ALUM-NUS, Dickinson College, Carlisle, Pa.

# Two Professors Honored in First Year at College

**T**WO veteran teachers have been honored by the College since coming to the faculty within the past year. Prof. Joseph Schiffman, formerly of Long Island University, became chairman of the English Department in February. Prof. Henry L. Yeagley, a teacher of physics and astronomy at Penn State University for 30 years, was named to the new Joseph Priestley Chair of Natural Philosophy in March.

Prof. Schiffman graduated from Long Island University in 1937, earned a master's degree at Columbia and his Ph.D. at New York University. He taught at L. I. U. for 13 years and was coordinator of the university's Graduate American Studies Program at the time of his appointment to the Dickinson faculty in September as professor of English.

A literary historian and critic, he is the editor of a volume of readings for the American Heritage Series of the Liberal Arts Press and the author of the preface to the Harper Modern Classic edition of Edward Bellamn's *Looking Backward*. He has served on occasion as manuscript adviser for the Harvard University Press, Duke University Press, *American Literature* magazine and others. His articles and book reviews number more than a score.

Prof. Schiffman serves on the bibliography committee of the Modern Language Association of America. For the past two years he was president of the American Studies Association of Metropolitan New York. As head of the English Department, he succeeds Dean Frederic W. Ness who held the chairmanship for a number of months on an interim basis.

The new Joseph Priestley Chair to be occupied by Prof. Yeagley was created by an endowment gift from S. Walter Stauffer, '12, a trustee of the College, and William H. Baker, both of York, Pa., in memory of Salome Baker Stauffer who died last November. She was the wife of Mr. Stauffer and the sister of Mr. Baker.

The chair is still another memorial at Dickinson to the 18th century theologian and scientist whose services to mankind are recalled each year at the College through its Priestley Award and Priestley Day celebration. The term "natural philosophy" as applied to the chair is in keeping with the terminology of Priestley's day. The term was used for natural science, and it appears in Dickinson catalogues as late as 1823 to indicate science courses.

Prof. Yeagley came to the faculty last July 1 as chairman of the Department of Physics and director of the Oscar O. Bonisteel Planetarium. He planned and supervised the complete modernization of the old Tome Scientific Building and the installation of thousands of dollars of the latest equipment for the teaching of physics and astronomy.

The story of his appointment to the faculty was carried in a previous issue of THE ALUMNUS.

### Spring Sports

Dickinson is having another good spring sports season. The track team was undefeated through its first six meets and the tennis team lost only one match out of the first seven. The baseball nine, getting strong pitching but weak hitting, won four and lost five while the lacrosse team, in contrast to the great record of last season, was able to defeat only Gettysburg in the first five outings.

### At Rutgers Inauguration

Linette E. Lee, '09, was the delegate of Dickinson College at the inauguration of Dr. Mason Welch Gross as president of Rutgers—the State University, at New Brunswick, N. J., on May 6.

Miss Lee is also serving as chairman of the Class of 1909 reunion to be held at the coming commencement.

### **Receives Two Honors**

Sidney W. Bookbinder, '35, lawyer of Burlington, N. J., was given unexpected recognition in January and again in March.

In January he was given the Distinguished Service Award as the "Outstanding Boss of the Year" by the Greater Burlington Junior Chamber of Commerce.

In March he was named "Man of the Month" by the *Delaware Valley Council News.* This organization is a citizen group whose mission is to act as a sounding board to assure the orderly growth of the Delaware Valley. ### Wins Foundation Scholarship

Gene Evans, '49, a star of Dickinson's great basketball teams of the post-war years, who graduated with Phi Beta Kappa membership, has not lost his formula for combining scholarship and athletics successfully.

In March, he received a National Science Foundation scholarship for a full year's graduate study at the University of Michigan just as the Carlisle High School basketball team he coaches won the conference championship for the fifth time in eight years under his tutelage.

Evans, who already holds a master's degree in education, hopes to earn an M.A. in mathematics during his year at Ann Arbor. His school has given him a year's leave of absence. He will enter the university in September.

## **Bulletin Lauds Schoolman's Service**

**R**OBERT E. MINNICH, '19, of Cohoes, N. Y., was the subject of a personality sketch featured in the December, 1958 issue of the *Bulletin to the Schools*, published by the New York State Education Department. He is an associate in school attendance in the Education Department.

He was also on the debating team, won several oratorical contests, was editor-in-chief of the *Dickinsonian* and graduated in 1919 with an A. B. degree. There was an interruption in his college career by service as a second lieutenant in World War I.

Following his graduation, he taught in the schools at Argyle, N. Y. and then became principal at Wells, N. Y. For three years he was supervising principal at Fort Plain and fourteen years as superintendent at Tupper Lake, in the heart of the Adirondacks. He has been with the State Education Department since 1946.

Active in professional organizations, Bob is a life member of the National Education Association and a member of the State Teachers Association, the International Association of Pupil Personnel Workers and the New York State Attendance Association. He is presently on the board of directors of the education chapter of the New York State Civil

## Life Membership Roster Lists 2,106 Names

THE roster of Life Members of the General Alumni Association, published annually in the May number of THE DICKINSON ALUMNUS by direction of the Alumni Council, lists a total of 2,106 names on the following pages.

Since the February number of the magazine was printed, ten new lifers have been enrolled to make a gain of 158 for the year and to raise the total from the 1,948 names published last year to 2,106.

### Makes Gift to Library

The long and fruitful career in Christian scholarship of Dr. Edmund D. Soper. '98, echoes in many ways that of one of his teachers at Dickinson, Henry Martyn Harmon. In the Library's Dickinsoniana Collection, shelved beside the books written by Dr. Harmon, there is a Greek-English lexicon of 1889, Dr. Harmon's gift to Edmund D. Soper, and Dr. Soper's gift to the College. In it the recipient wrote, on Sept. 1, 1896, this tribute:

"Henry Martyn Harmon, D.D., LL.D., was born in Anne Arundel County, Maryland, in 1822. He was graduated from Dickinson College in 1848. After teaching in several institutions, he was called to fill the chair of Ancient Languages at his Alma Mater in 1870. This professorship, somewhat modified in scope in the course of the years, was held by Prof. Harmon until 1896, when he retired from his active duties and was made Professor Emeritus. He lived but a short time after his retirement, being called away on July 2, 1897. He went to enjoy the realization of the meaning of the words he so often used in ending a prayer, 'The power of an endless life'."

### A Woodrow Wilson Fellow

A Dickinson College senior who spent much of his youth under war clouds in his native Estonia and Germany is one of 1,200 superior American and Canadian students selected as Woodrow Wilson Fellows for the 1959-60 term.

The fellowship award of \$1,500 plus full cost of tuition and other fees will enable Jaak Vilms, of Seabrook, N.J., to do graduate work in mathematics at the University of Chicago next term. He will graduate with high honors in June.

The fellows were chosen by the Woodrow Wilson National Fellowship Foundation from 7,000 candidates nominated by their teachers in a nation-wide talent hunt for future college teachers. The program, backed by a Ford Foundation \$25 million grant, is a phase of the national effort to meet the critical shortage of qualified teachers.

Vilms was tutored by his mother while the family were refugees in Germany after fleeing from Estonia to escape the invading Russians. The family came to the United States in 1949.
