Now that I am an enthusiastic convert—a true-believer in the sincerity of the alumni program—my mission is obvious: convincing others that the College means what it says. An active, involved, and concerned body of alumni is as essential to the College as a roomful of fabulously wealthy benefactors.

Indeed, support for the College—in terms of both gifts and input—has grown at a most encouraging rate. The number of contributors to the 1974 Dickinson Fund rose almost 20 per cent over 1973.

That's a pretty strong message that the alumni care. And the College in turn is quick to acknowledge its dependence on, and gratitude for, alumni contributions of all kinds. You can take that from one who was glad to discover he was more than just a checkbook - glad enough, in fact, to volunteer a testimonial. And the Army taught me never to volunteer!

Summer Telethon Nets \$8,000

Annual Giving Up 12%

Unrestricted giving to the 1974 Dickinson Fund totaled \$276,735 when the final figures were tabulated last month, according to John Marcy, '72, assistant director of annual giving. This represents an increase of 12% over the previous year's total of \$247,612.

The total number of contributors (4,192) also increased by 18%, though the fund fell short of the projected goal of \$315,000. The total amount raised was 88% of the '74 target.

The number of alumni givers to the fund rose 18%, while the dollar amount of alumni gifts rose 19%. The dollar total of parent gifts dipped by 2%, though the total number of parent contributors increased by 31%.

Gifts from foundations were up by 35%, though corporation gifts declined significantly from \$32,976 a year ago to \$26,199—a drop of 21%.

The combined totals of the Dickinson Fund and special purpose gifts rose to \$365,426, nearly \$40,000 above last year's total of \$325,461. Dickinson Fund gifts are unrestricted and applicable to current operations, while special purpose gifts go to specific ventures, such as the Judaic Studies Program.

Dickinson Fund totals were given a shot in the arm as a result of the four-day telethon in June, which netted pledges totaling \$8,000. This was almost double last year's telethon total of \$4,500.

John Marcy, who coordinated the phone campaign, noted that its success is due exclusively to the 35 volunteers.

"What's significant is that these people were 'willing' helpers," Marcy said, "not people who had to be coerced to sit down with a phone and stack of cards.

Alumni callers bridged the generation gap in that they ranged from the Class of 1972 all the way back to the Class of 1907. Younger callers included Jim Henry '72, Jay and Karen Layman '71, and Kevin Hess '69. They were hard put, however, to match the enthusiasm shown by George Briner, of the Class of 1907 and Mabel Krall Burkholder, of the Class of 1914.

Nearly 1,000 calls were dialed between the hours of 7 and 9 p.m. (EDT), from June 10 through 13. Just over 500 contacts were made (about 5% of all currently listed alumni), and callers reported a 70% positive response.

"I was expecting a lot of quick rejections on the basis of tight finances," one caller remarked, "and I expected a lot of people to ask 'Why do I owe Dickinson College anything?' But those kinds of responses were actually rare."

"Most of my friends were really glad to hear from me and hear about what's going on at school. Some people only had \$5 to give, but they gave it. I didn't really have to do any arm-twisting or teeth-pulling. Most people realize we need the money and didn't at all mind sending something in."

Students, Managers Key into the Sensitivities of Workers on the Assembly Line

Can American Cars be Built to Last More than 2 Years?

Some day we may be able to buy an American car that lasts more than two years—if Professor Ben James has anything to say about it.

The perceptive Dr. James this summer initiated a threeweek course aimed at keying into the sensitivities of the assembly line worker, and examining the problems of labormanagement communication.

"The message I most wanted to get across," says James, "is that the laborer is a human being, with his own sense of dignity and worth. It's only natural, therefore, that he'll be at his productive best when he is treated as such."


James, an alumnus of the college ('34) who has been teaching psychology here for 33 years, labeled his course: "Management Effectiveness through Self-Directed Change." The fancy title implies simply that it's up to each manager to make himself aware of what makes his employees tick.

In concept and enrollment, the class was a first, since it involved eight experienced managers from Carlisle industries and six selected undergraduate students.


Although James has had the concept in mind since the early 50's, it wasn't until last winter that the idea crystalized—with the help of a former student, now president of Daily Industries, D. E. "Ted" Lutz ('47).

"Ted was in Atlanta last winter for a top management conference," James recounts, "and he returned with the feeling that the real nuts-and-bolts problems he faced as an employer were never really tackled. The sessions he attended on management problems simply didn't meet up to his expectations."

Consequently, James and Lutz got together to design a more practical program. "I told Ted that if he would take care of the industrial aspects, I'd take care of the psychology," James says. "He agreed, so we started putting something together."



Prof. James believes low productivity can sometimes be attributed to the fact that workers are not treated with a proper sense of dignity and respect. He did some lecturing on the subject, but more often had his students act out worker or supervisor roles, to dramatize real-life situations. Students also visited several Carlisle manufacturing plants for a look at assembly-line techniques.



One of the benefits of the course was that students had their theories challenged by experienced managers and supervisors who face, on a daily basis, the problems under discussion.

James then began contacting the four men who, in his words, "made the whole course possible through their cooperation"—William Masland, president of the Masland Corp. (and a new trustee of the college); Joseph Brenner ('39), president of AMP Corp.; Carrol Warrell, president of Carlisle Tire and Rubber Corp., and Claude Lewis, president of the Kinney Corp.

"It seems they too were tired of sending people to national meetings in New York or Chicago which seemed to accomplish little," James adds. "And they were especially happy to take part in a local seminar, which would focus more on their own individual problems."

So with the groundwork established, each company enrolled two managers. James selected six students, and the course was conducted under what Dr. James calls the laboratory-workshop format.

"The laboratory idea," James says, "is that a person brings in his problem and then the total group helps him work on it. The manager not only learns theoretically, but can go right back to the business and apply the knowledge."

The class discussed case studies from the three texts used, and, James says, "we also had them on TV where they could see themselves in an interview situation. It was ideal because we had a manager interview a student, and both groups benefitted a great deal."

During the three weeks of intensive study, the class hashed out management problems ranging from nepotism to socializing with employees after hours, to salary problems.

"One of the major problems of industry," James says, "is achieving communication from the bottom up, to know what the employee is thinking—especially in relation to such things as unionization and salary."

"Salary," he explains, "can many times be a 'dissatisfier, contrary to what most people think. It is satisfying to a point; but when you go beyond that and you give one fellow an increase, it can become a dissatisfier. When one man gets the increase, everyone around him wants similar treatment; and the same goes for promotions."

"A great deal of time," James says, "was spent on discussion of programs to make the worker feel involved, and believe the work he does is important."

"We talked about how each of the four companies could further enrich their programs," he elaborates. "One of the things that can be done, for instance, is that instead of asking the person to do just one thing, you might get him to assemble a whole unit - so that he feels a greater sense of pride and achievement."

The course had the twofold purpose of helping the managers understand not only their workers but themselves. James used extensive interaction sessions as his key to the course's success.

"I stress the idea that you understand yourself first in any situation; then you make every effort to understand the other person. Finally, you focus in on the subject of the situation.

"Commitment is not enough," he continues. "Many times people will commit, but the important thing is the action that follows."

The success of the course was revealed in the students' and managers' evaluations, handed in the last day of class. Out of a possible 20 points, most rated the class 15 or higher.

Managers from each of the companies took students on a tour of their corporate facilities after the course was over. And a reunion is planned for October, at which time managers will brief students on the success of various suggestions made throughout the course.



How do you pick a president?



a report on the work of the trustee and campus search committees*

The process of choosing a college president is far from a simple administrative chore.

No one is more aware of this than the College's Board of Trustees, who, for more than half a year, have been engaged in a search for a successor to Dr. Howard L. Rubendall.

Selecting a president is undoubtedly

a board of trustees' most important function. And, at a time when a continuation of good leadership is vitally important, the very nature of the selection process itself is a matter for the most serious consideration.

Thus the board's first step, when Dr. Rubendall announced his retirement, was to consult with other colleges and universities which have recently

selected new presidents. The details of search procedures used at these institutions were studied carefully.

And a plan emerged—based in part on a study published in *The Chronicle of Higher Education*—recognizing the need for maximum input not only from board members, but from alumni and all segments of the campus community.

*The All College Advisory Committee on the Selection of a New President was formed last winter to aid the Trustee Selection Committee to screen candidates. Trustee committee members are Samuel W. Witwer '30 (chairman), William S. Jenkins '31, W. Gibbs McKenney '39, Dr. Mary Ames

Raffensperger, E. Donald Shapiro '53, J. William Stuart '32, and Harry C. Zug '34.

The all college committee consists of five faculty members (Mary DeGrys, William Jeffries, Philip Lockhart [chairman], Enrique Martinez-Vidal and Noel Potter); two administrators

(Mary Frances Carson and John Woltjen); two students (Kathy Bachman and Tom Nickels); and one alumni representative (Jack Stover '70). The final nominee will be determined by the trustee committee and submitted to the full Board of Trustees for ratification.

A formal "Trustee Selection Committee" was established in mid-winter, with the stated goals of studying the future leadership needs of the college, establishing guidelines for candidate qualifications, and recommending a final nominee to the full board for ratification. This committee, chaired by board president Samuel W. Witwer, consists of seven members, six of whom are alumni.

Appointed at the same time was an "All College Advisory Committee," consisting of faculty, administrators, students and an alumni representative. This group, under the chairmanship of Professor Philip Lockhart, was charged not only with the task of helping define criteria and leadership needs, but of communicating to the trustees the range of sentiments being expressed on campus regarding the presidential appointment.

Jack Stover '70, who represents the president of the General Alumni Association, is one who has been involved in many long discussions on what a president should be and where suitable presidents might be found. And he is convinced that the advisory group represents a voice that is being listened to.

"Mr. Witwer (president of the board of trustees and chairman of the trustee search committee) has had us heavily involved since the beginning," Stover says, "and I don't think there's a doubt in the mind of any committee member that we are helping to select the next president."

The first notable chore assigned by the trustees to the all campus committee was to devise a job description for the presidency.

This was easier said than done, since the statement had to be specific enough to be meaningful, yet general enough to

include candidates from diverse backgrounds.

Naturally, committee members tended to think in terms of ideals: someone who could inspire all segments of the community; someone with a distinguished scholarly background; someone with proven administrative ability.

The big question: Does such a person exist? If so, can such a person be found? If so, will he or she want to come to Dickinson?

Eventually, the assemblage came up with a three-page list of criteria, most noteworthy for the fact that it contains no "sine qua nons." That is, there is an absence of arbitrary prerequisites. The candidate need not necessarily be a man, an alumnus, a theologian, a Ph.D., or someone from within the college—though none of these is excluded.

The committee's statement does set up a few specific goals, however. A candidate is sought who: "knows the broad picture of higher education and the role of liberal arts colleges;" and who has "native sensitivity, common sense, and an instinct and sympathy for what is unique about Dickinson."

While nominations were invited from the overall body of alumni, few were received in the initial stages. Thus representatives of both the trustee and advisory committees, including Harry Zug, vice chairman of the trustee group, visited the campus on Alumni Day in May to solicit comment and criticism on the search committee's role.

Most of the questions concerned criteria, according to one representative. "People wanted to know who the search was limited to," he recalls. "They wanted to know whether the salary and benefits were competitive enough to attract top talent; whether the search was nation-wide or regional."

Jack Stover notes that many of the alumni queried him on whether or not they were to play more than a peripheral role in the selection process. "I responded," he says, "by reaffirming the sincerity of the College in its efforts to achieve maximum alumni participation."

So far, over 125 names have been the subject of conversations, interviews and investigations, including those names forwarded by the campus advisory committee.

In-depth screening has been the continuous responsibility of the trustee committee, acting in concert with the Academy for Educational Development. Candidates' qualifications are

subjected to scrutiny, and those who appear most promising are contacted to determine interest in moving to Dickinson.

Chairman Witwer notes that the trustee committee hopes to arrive at a "manageable" number of candidates by early fall. These prospects will then be introduced to the campus and invited to meet with the advisory committee and other campus representatives.

Is the advisory committee pleased

with its progress so far?

Jack Stover, for one, says he's never served on any other college committee which worked with such a sense of consensus, despite varying viewpoints.

"There's been an honest attempt," he observes, "to include the full range of opinions found in a liberal arts college today. I think the overriding interest is to make the final decision one which comes from all, not just a part of the community."

Board president Witwer has also expressed satisfaction with the selection process, the quality of candidates considered so far, and the overall progress of the search.

"It is the determination of the trustee search committee to find a superb president for Dickinson," he commented recently. "We are confident that we will bring in a number of outstanding academics, one of whom will make a totally effective president."

finding the perfect person . . .

Few committee assignments could be more challenging than picking a president. Not only must the ideal candidate have a broad range of talents and accomplishments, but he must be able to impress and appeal to all segments of the college community.

Perhaps the best attribute to have while defining criteria for a new president is a sense of humor. Below are a few remarks which shed some light on the difficulties involved in locating the perfect person:

"(The new president) must be a leader - not too far to the right, not too far to the left, and, of course, not too much in the middle.

"He must be a magnificent speaker and a great writer.

"He must be a good public-relations man and experienced fund-raiser.

"He must be a man of iron health and stamina . . . a young man, but also mature and full of wisdom.

"He must be married to a paragon . . . a combination of Florence Nightingale and the best-dressed woman of the year.

"He must be a man of the world, yet he must also have great spiritual qualities - a great administrator who can delegate authority. "He must be a Yale man and a great scholar . . . a social philosopher who has at his fingertips a solution of all world problems, from birth control to Formosa

"As I have been talking, .. I don't doubt you have realized that there is

only one who has most of these qualifications ... but the question is ... was God a Yale man?"

Recently there's been a lot of talk about a "fifties craze." It's not a "craze," really, but another social fad that Dickinson and other schools have managed to assimilate.

In an era when earrings and Eisenhower jackets appear on college men—and headbands and rucksacks on women—it's not surprising that the American college campus is also accommodating Elvis' blue suede shoes.

Go to certain parties here these days and you'll hear Elvis crooning "Don't Be Cruel" and "Heartbreak Hotel." You'll see dance steps that recall the Stomp, the Slop, the Birdland and many other slick-named variations of the jitterbug.

And, last spring at least, you would have noticed that the neatest stepper in the group was Elissa Aks. Elissa graduated in June, but her legacy as the college's number one jitterbug artist lives on.

The irony in this is that while nostalgia for the fifties was strongest a year or so ago, Elissa wasn't even aware of it. She caught the trend on the downbeat, after returning from the I.E.S. (Institute of European Studies) program in Nantes, France. It was there that she picked up "le roc," a jitterbug which in France has never needed reviving because it never stopped bopping.

Elissa returned to Carlisle for her senior year and found that although saddle shoes had reappeared, they were more often seen in the classroom than on the dance floor. She has since changed all that.

Elissa taught her male friends how to do the "boy's pass," how to roll one set of shoulders over another, how to sluice their partners between their legs, and turn them at the waist.

She brought "le roc" into the fraternity quadrangle and into the Holland Union. And she started a film about the dance for the benefit of future students in the Nantes program. All this might just constitute one of the happier meetings of French and American cultures in recent years.

For a generation attuned to acid rock and the uninhibited spasms that accompanied it, "le roc" posed the special difficulty of being a dance you actually have to learn how to do. The former suspicion—that dancing to a drummer no one else was hearing signified divine inspiration—had to be given up. To

dance that way any longer simply meant you were out of step.

Elissa now returns to campus only for an occasional weekend dance. But other students, what with all the effort they've put into learning "le roc," aren't about to abandon it simply because their instructress has left campus. Or because the rest of the move to "bring back the fifties" presumably will soon clank, Edsel-like, to its end.

Whatever Happened To Student Activism?

an interview with robert p. kane

(NOTE: Robert P. Kane, Class of '52, is an active alumnus who has been in state government for nearly 20 years. While serving as Pennsylvania's Secretary of Revenue, he keynoted the Carlisle Chamber of Commerce banquet honoring the College on its Bicentennial.

A parent of three children (Timothy, a senior at Dickinson; Kathy, a senior at Lehigh; and Dennis, a freshman at Mercersburg), Kane is well attuned to the mood of young adults today. In the following interview he talks about student attitudes toward political involvement and the impact of Watergate on the political system.)

QUESTION: One of the trends of the times seems to be not only that the campuses are "quiet," but that young adults have lost interest in the political system altogether. Do you get the feeling that young people have again fallen victim to apathy?

ANSWER: Yes, but the students aren't solely to blame. Historically, this country's number one problem was, is and will continue to be "apathy." Our attention skips from one national or international crisis to another; but we ignore the real problem of our times, which is that we have become self centered.

We depend on government to solve all ills. We've fallen into the trap of thinking that all community problems can be erased if we just send a check in to the I.R.S. If that were the answer, all our problems would be solved, because Americans certainly have plenty of money. Too many people shrug off involvement and say, "Let George do it." People escape to the suburbs and think they've escaped all the problems of crime, pollution, congestion, etc. As a result, we're losing a sense of community. I think it's time not only students but everyone took a long, serious look at our goals and institutions.

How can more young people be encouraged to enter careers of public service?

I think the situation would be helped if public service weren't always characterized so negatively.

Sensationalism regarding occasional misdeeds implies that public service is something less than desirable. I fear to know how many people have been chased out of office, or discouraged from entering, because there was so little positive reporting about the accomplishments which were being made. You only hear about the failures today. The good never seems newsworthy.

Let me cite just one example. Every day 12 million Pennsylvanians take care of 700,000 poor. You hear a lot about the 6 per cent that are on welfare, but you never hear about the 94 per cent that aren't.

A basic Judeo-Christian ethic governs our behavior, spurs us to help our fellow man. But you never hear about welfare in any other terms except how many are trying to cheat the system. Few people realize that most of those supported by welfare checks are children. What, pray tell, do you do with them? Let them starve?

Does the quiet mood of the campuses today signal an end to the idealistic fervor of the sixties?

I'd have to say that even the great surge of late-sixties activism never materialized politically. If you saw the results of the 18-year-old vote you'd repeal it. The kids have generally been even worse than their parents, when it comes to participation.

I think young people can be credited with ending the war, but for some reason the impetus of the anti-war movement never carried through. I would have thought young people would go on to prick the national consciousness on amnesty.

What do we do about the quarter-million young Americans who had to flee the country because we provided no constructive alternatives to military service in Vietnam? They're war casualties too, Do we just forget them? I would think our youth would be prodding us on that question, but they're not.



Confrontations are no longer in vogue

Why not?

Because they're cynical, I guess.

Is that cynicism justifiable?

No. This generation has an obligation to speak up and participate. They have to retain their idealism. Too many young people are walking away. They're exploring society's problems as students, but failing to follow up. Nonetheless, the system has demonstrated again and again that it works. The war was brought to an end because of overwhelming popular disrespect. Look at the debate on impeachment. Where else on earth could you have such an orderly debate on such a volatile issue? In Portugal they had to have a revolution to accomplish the same end.

Robert P. Kane, 43, is a 1952 graduate of the College. He majored in economics here and then went on for a legal degree at Dickinson School of Law.

Kane began a career in state government as a corporate tax officer in the Pennsylvania Department of Revenue in 1956. He later served on the Democratic State Committee and worked as a Congressional administrative assistant before his appointment to Governor Shapp's cabinet.

In 1971 he became Secretary of Rev-

enue, supervising a 3,500-employe department. Kane helped initiate the state's lottery, and helped administer the state's first income tax and the senior citizen's property tax assistance program. He was also responsible for collecting corporation, sales, cigarette, liquor, fuel, inheritance and horseracing taxes. He resigned this year to head up the governor's reelection campaign.

He and his wife, the former M. Celine Eck, are the parents of three children and currently reside in York PA.

Whatever Happened to Student Activism?

Will this generation of students provide the leadership that is needed in the future?

There's no doubt that the greatest shortage in this country today is not a shortage of gasoline, paper or plastics but a shortage of leadership. There are too many leaders now who are so afraid of making mistakes that they don't make decisions. They defer everything for study or appoint committees. But I have yet to see a monument to a great committee.

Let me add that I see many good people coming into government service and staying. One state cabinet officer confided to me he'd never worked so hard in his life for so little money. He gave up a fortune to take his job and he's been abused by critics since the day he arrived. People don't put up with that if they're just in government to "take care of themselves."

What do you think will be the longterm impact of Watergate on our society?

Well, I see people groping for a new sense of values. Watergate has proven that there is a great hunger for moral leadership. It could be the best thing that ever happened in this country if we seize upon it, if we demand higher standards and implement that demand.

If the only result of Watergate is some short-term advantage of Democrat over Republican, it will look like hell in the history books. In short, then, you find no reason for deep despair over the future of American politics?

By no means. The vast majority of people who run for office are clean, honest and committed. I don't think we've had or have a lot of corrupt people. As I said before, media spotlighting tends to exaggerate the problem.

Watergate was the result of about 50 or 60 people who were corrupted by power and money. But there are nearly 3 million persons on the federal payroll. So how corrupt is the federal government?

I think we're headed up, not down. A lot of people believe in the system and are working to make it better.




