BIOGRAPHICAL NOTE

Andrew Blair was born in 1789, presumably in the Carlisle, Pennsylvania area. He owned and worked a small farm in Carlisle. In 1833, Blair petitioned the Presbyterian Church in Carlisle to allow the creation of a second Presbyterian Church, separate from the first. He had disapproved of the work his current pastor, Rev. George Duffield, was doing on "Regeneration." Blair's petition was granted on January 12, 1833 and the Second Presbyterian Church of Carlisle was founded. This matter caused Andrew some scandal, of which he felt necessary to clear his name through correspondence. Regardless, he remained an elder in the new church and was given charge of the mission Sunday school. Andrew Blair also served as president of the board for both the Faculty Teachers of the Common Schools of Carlisle and the Board of School Directors of Carlisle. Clearly, Blair was an active and respected member of his community.

After the death of his wife, Andrew Blair went to live with his older brother William just outside of Carlisle. The brothers resided together until Andrew's death in 1861. William passed away later during that same year.

Andrew Blair and his wife had three children: Ann Blair Murray, Andrew Holmes Blair, and Elisa Blair Bailey. Daughter Ann married Rev. Joseph Alexander Murray, and the couple had a daughter named Mary.

COLLECTION DESCRIPTION

The Andrew Blair Family Collection is housed in one document box and is organized into two categories: Correspondence and Miscellaneous Materials.

The Correspondence are arranged alphabetically by the author of the letter or note, and then chronologically. The letters themselves are mainly concerned with family affairs and local events. The bulk of Andrew Blair's correspondence consists of letters to his son-in-law, Rev. J. A.

Murray, in which Andrew advises him on personal as well as congregational matters. The letters of William Blair, written largely to his niece and grand-niece, record several traumatic events in Carlisle history, such as devastating fires and outbreaks of illnesses. When possible, envelopes have been retained along with the letters.

The Miscellaneous Materials are arranged alphabetically by the family member about whom the materials are concerned. Included among these materials are papers regarding William Blair's membership in the Philadelphia Typographical Society, an "Appropriations" list maintained by Andrew Blair concerning donations taken to help victims of the Carlisle fire of 1835, newspaper clippings with obituaries of Andrew Blair, and a Carlisle Town Council notice sent to Robert Irvine regarding the repaying of High and Hanover Streets with brick.

Included with this collection is a single photograph of William Blair, copied from a Daguerreotype dated 1848.
