BIOGRAPHICAL SKETCH

Thomas Hamilton, native of Belfast, Ireland, was born circa 1767. Having received his education at Belfast, he immigrated to America in 1785, and resided for some time with his brother, James Hamilton, in Carlisle, Pennsylvania. In 1788 he moved to Greensburg, PA and in 1793 was appointed prothonotary of Westmoreland County. He continued in that office until 1809 when he took up residence in Kittanning, and there he remained until his death on August 16, 1829.

James Hamilton, to whom the majority of the letters in this collection are addressed, was a prominent Carlisle figure. Born in Ireland in 1752, James Hamilton immigrated to America sometime before the Revolutionary War. He held the office of Deputy Attorney-General (or Prosecuting Attorney) prior to being appointed President Judge of the Ninth Judicial District in 1806. James Hamilton also served as a member of the Board of Trustees of Dickinson College from 1794 until his death on March 13, 1819.

COLLECTION DESCRIPTION

The Thomas Hamilton Collection is housed in one document box and the materials are divided into two series: Correspondence and Miscellaneous Materials. The Friends of the Library purchased this collection in 2002, with additional financial support from private donors.

The series entitled Correspondence consists almost exclusively of letters received by James Hamilton from his brother Thomas Hamilton. The letters range in date from 1789 until 1818 and cover a variety of topics, including financial business and accounts, legal cases, local and national politics, family news and religion. The letters also reflect Thomas and James' activities as land speculators in Pennsylvania, Ohio and Kentucky. The collection also contains two letters not sent by Thomas to James Hamilton. One is from Ann Power, daughter of Thomas Cruse, to her uncle, James Hamilton and the other is from James Hamilton, Jr. (Dickinson class of 1812) to Thomas McConnell, his cousin.

The series entitled Miscellaneous Materials consists of three items, two being financial accounts and the third being a notebook maintained by Thomas Hamilton. This notebook consists of various notes on matters pertinent to Thomas' financial accounts, active court cases and organizations in which he was interested or a member. The notebook also includes miscellaneous notes, such as a list of elected government officials, United States acreage statistics, a list of taxable inhabitants by Pennsylvania county, and election results, among other items. Short essays on religious matters are also included.
