BICENTENNIAL CONFERENCE ON GAYS AND THE FEDERAL GOVERNMENT

Over the past several years, there has been a growing realization that the federal government has as enormous impact on the lives of America's 20 million gay men and women. This conference is being called to explore a number of ways in which this impact is being felt. The purposes of the conference are to more clearly define the goals of gay in the federal context, to contribute to the mutual education of those interested in the rights of gay people, to improve communication, and to and to provide a basis for effective remedial action. Throughout the planning of the conference, the emphasis has been on information-sharing and the open exchange of perspectives. The panelists and speakers for the conference will be announced, on August typ1975; The list will include individuals active in the gay movement and many who have been active in other causes or who have some important related experience to bring to the issues of this conference.
