Also, along with one of the speaking engagements HOW would like to experiment with a coffee-house. If anyone would be interested in setting up the coffee-house and determining its format, please contact HOW by mail or speak to one of its officers. This type of event would provide an alternative to the one and only local bar as an opportunity for gays to meet and socialize in a more relaxed setting. We are all aware of the evident shortcomings of the local bar as a place to meet people, and we have all at one time or another bemoaned the lack of suitable occasions and places for socializing. Well, this is your chance to substitute some positive action for negative complaints. If the experiment is successful, HOW would definitely sponsor similar coffee-houses on a more or less regular basis. We would, of course, have to line up some entertainment for these coffee-houses, such as guitarists, vocalists, or even a well presented disco evening. What we need now, however, is a show of hands of those who would help to work to create the first of these coffee-houses. You have nothing to lose but your boredom.

With much regret I must tell all our readers and friends that I have been driven out of my residence at 659 Beeber Street. The attacks upon the house became so severe and malicious that I felt I had no alternative. The attacks included those on Halloween when windows on all four sides of the house were hit with numerous objects and those in November when the front door was broken in with cinder blocks which were lying on the livingroom floor when I entered the house. I cannot return to the house to live for if I do, the attacks will start up again. I have been out of the house for a week now and in that interval the house has sat untouched. Relatives have given me temporary refuge; I may remain a vagabond for quite a while. Pat may let me stay in her place for two weeks in December while she is away. I wish publicly to express my gratitude to Mike D., Richard, and Wayne in the local gay community for their help and support. Others in the local gay community have ignored my problems, especially those at the bar.

I am afraid my troubles have affected the organization directly as the people seem unwilling to venture to new addresses for meetings and functions. There will be no more functions at 659 Beeber Street !!! Will there be a HOW ???
