## College To Receive \$406,400 From Ford Foundation

**D**ICKINSONIANS, faculty members, trustees and friends of the college rejoiced in December when newspapers carried the story that Dickinson College would receive \$406,400 from the Ford Foundation and that an asterisk appeared before the name of the College in the printed accounts, meaning that Dickinson would receive a Basic Grant and also an Accomplishment Award. Only one of every ten colleges in the United States was selected for the Accomplishment Award.

The Basic Grant consisted of a pro rata share of the sum of \$210,000,000 appropriated by the Foundation for the support of all privately-financed accredited liberal arts colleges in the United States. Six hundred and fifteen colleges shared in this distribution. The apportionments to the various colleges were figured in proportion to the faculty annual payrolls in Arts and Sciences, and consisted of a sum equal to approximately 96% of a single year's payroll for this purpose. The amount granted to Dickinson College under the Basic Grant distribution amounted to \$270,934.

The second part of the allocation was the Accomplishment Award, which consisted of a pro rata share of the sum of \$50,000,000 appropriated by the Ford Foundation for distribution to those colleges which, in view of their resources, had already demonstrated commendable progress in advancing the salary and status of faculty members. One hundred and twenty-six colleges were selected for the Accomplishment Award. The sums awarded individual colleges were determined by taking approximately one-half of one year's payroll for faculty in Arts and Sciences. The amount of the Dickinson grant under the Accomplishment

Award amounts to \$135,466.

The Ford Foundation grant figures as follows:

The funds under the Basic Grant are restricted in their use to the improvement of faculty salaries. The funds must be invested and only the income used for this purpose. After ten years this restriction will cease to be effective and the funds may be used for any purpose the Trustees of the College may decide.

While use of the Accomplishment Grant is not restricted, and may be used for any purpose the Trustees may decide, the announcement of the Ford Foundation reads: "The Accomplishment Grant, either principal or income, may likewise be used for faculty increases, or it may be devoted to other pressing academic needs."

The total grant of \$406,400 is an approximate figure and will be adjusted in accord with final computations by the Ford Foundation itself. It is not anticipated that the change will be more than 2%, and may be either up or down.

In the excitement of the announcements, many thought that checks were on their way to the colleges last December. The fact is that one-half of the total will be distributed in June 1956 and the other half in June 1957. It will therefore be June 1957 and June 1958 when income will be received from the investment of these awards and funds will be available for faculty salaries.

While the Ford Foundation Basic Grant will be of great help, it does not solve the problem of income for faculty

salaries. Dickinson College needs additional millions of dollars of endowment for this purpose. There is no doubt that by its action the Ford Foundation has focused the attention of many others on this tremendous need in all of the privately-financed colleges. That the Ford Foundation hopes its action will result in greater benefits is evident in its own statement reading: "It is the expectation of the Foundation that the colleges receiving the Accomplishment Grant will make every possible effort, during the next few years, to obtain at least equal financial support from other sources further to increase salaries. Therefore, no formal matching requirement is made."

Members of the Dickinson family can take pride that the College was selected for the Accomplishment Award. It is interesting to note that seven such awards were made among the 58 privately supported colleges in Pennsylvania. The seven awards made to Pennsylvania institutions appear to fall in the following groups: (a) representing large universities, the University of Pennsylvania;

(b) Catholic institutions, the University of Scranton; (c) Negro institutions, Lincoln University; (d) women's colleges, Bryn Mawr; (e) men's colleges, Haverford; and finally (f) co-educational colleges, Swarthmore and Dickinson. Since, there are nearly 30 co-educational liberal arts colleges in Pennsylvania, the selection of Swarthmore and Dickinson as the only representatives of this group seems to be a significant judgment on the part of the Ford Foundation.

In a letter to the Trustees of the College reporting the Ford Foundation Awards, President William W. Edel concluded by saying: "You are aware that the Accomplishment Award came to Dickinson College only because you, as Trustees of the College, supported and made effective the recommendations made to you from time to time concerning improvements in the salary and the status of members of the Dickinson faculty. I express my warmest appreciation for the support which has enabled us to be so signally honored."

## Trustees Reaffirm Position On Use of Intoxicants

**P**RECIPIATED by events which occurred during Homecoming a month earlier, the Board of Trustees at their December meeting reaffirmed their position on the use of intoxicants.

Several disciplinary cases grew out of happenings at Homecoming which created a turmoil among students, faculty and alumni. The students asked for a review of the College regulations concerning the use of intoxicants and President Edel reported the matter to the Trustees. The situation was discussed at great length by all members present at the meeting when the following resolution was adopted: "That we reaffirm the position of the Board of Trustees on the regulations. For the information of all concerned, the following regulations which have been in effect many years, are re-stated:

1. The College strongly disapproves of the use of intoxicants.
2. In particular, the possession or use of intoxicants on College property, in dormitories, fraternity houses, or at College functions, is prohibited.
  - a. Disorderly conduct while under the influence of intoxicants will not be countenanced.
  - b. Women students are not permitted to enter establishments where the sale of liquor is the primary business. This does not forbid women students from taking meals in bona fide hotels and restaurants where the service of liquor to other diners is incidental to their meals.
3. Violation of these regulations will lead to severe disciplinary action."

## Leave All To Enter Mission Field in Nepal

**T**HROUGH the years, many Dickinsonians have served as missionaries in foreign fields but the story of Dr. Edgar R. Miller, '20, and Dr. Elizabeth Bucke Miller, '23, his wife, who gave up lucrative practices in Wilmington, Del., their fine home, and their family and are now in the high seas en route to a new life as medical missionaries to Nepal is one of the greatest stories ever told.

They sailed on February 7 on the S. S. Steel Surveyor, an Isthmian Line freighter, from Brooklyn, N. Y. with tons of equipment, on a 40-day voyage to Calcutta, India. There they will be flown by cargo plane to Kathmandu, capital of Nepal, northernmost neighbor of India and at the foot of the Himalaya Mountains.

At Kathmandu, they will join Bethel Harris Fleming, M.D., a medical school friend of Dr. Elizabeth and a Wilson College graduate, and her biology teacher husband, Robert Fleming, Ph.D., who pioneered in Nepal in 1953 and where they have already set up five roadside medical centers. The Flemings have been

in the mission field for over 25 years.

The Flemings will rejoice in the arrival of the Millers, who will have with them medical books for Nepal's first medical library, two Jeeps, and much medical equipment. Included in this is an up-to-date X-ray machine, equipped with fluoroscope, which cost \$6,100 and was given by the Richardson Park Methodist Church of which the Millers are members. They are also taking a \$775 electro-cardiograph machine which was presented to them by the Methodist Church in Philipsburg, Pa., where Elizabeth's brother, the Rev. D. Perry Bucke, '29, is pastor.

In leaving for Nepal, the Millers are fulfilling the desire they first expressed 28 years ago. After they graduated from medical school, and their marriage in 1927, they appeared before the Methodist Committee of the United Missions Board and offered themselves as medical missionaries. They both then owed their families the expenses of their education and the committee told them in the words of Dr. Edgar "to go out and practice, repay our families, and then plan

for a foreign career."

Since then the responsibilities of raising two children, caring for other relatives and the demands of their careers prevented them from doing what their hearts desired. Their children are now grown and married. Their son, Dr. Edgar R. Miller, Jr., has two children and is doing his residency in surgery at Strong Memorial Hospital, Rochester, N. Y. Their daughter, Mrs. William Jenkins, lives in Wilmington with her husband, a Ph.D. in chemistry, who is with the duPont Company.

Through the years, Dr. Elizabeth has had an extensive community and private practice—what she has called "a truly rich experience in the field of general practice." In 1937-38 she went with her husband to Vienna, London and Boston, where they did post graduate work in medicine.

Dr. Edgar Miller has been outstanding in Delaware medical circles for years. Since 1930 he has been one of the chiefs on medicine at the Delaware Hospital and chief of cardiology there since 1938. He has been a Fellow of the American College of Physicians since 1930 and is a past president of the Delaware Academy of Medicine and the Delaware Heart Association. He has contributed a number of articles to various medical journals.

These are the careers on which they have closed the book. They sold their lovely home, their automobiles and they left the comforts of gracious living for what Dr. Edgar calls "a challenge we've always wanted." Their combined salary from the United Missions Board will be \$2,350.

Yet before them lies Nepal with only 84 miles of roads in a land about the size of Iowa and with 7,000,000 inhabitants, where there is a low level of public health and where there are many parasitic diseases. There is little doubt that the Millers will find a challenge there.

Dr. Elizabeth was born in a Methodist parsonage, the daughter of the Rev. J.

E. A. Bucke, D.D., who received his degree from Dickinson College. She graduated from Williamsport High School and from the college in 1923 and received her A.M. in 1927 when she also graduated from Women's Medical College, Philadelphia. She is a member of Phi Mu, Zeta Phi, the Delaware State Medical Association and the New Castle Medical Association.

Dr. Edgar was born on April 19, 1899 in New Freedom, Pa., and graduated from the high school there and from the University of Maryland Medical College. He is a Mason, a member of the Shrine, Phi Chi Fraternity, the American and Delaware Medical Associations.

### On Mission to India

Dr. Janet A. Kelley, '24, professor of education at the City College of New York, is on a mission to India to help the educational leaders of that country revise and strengthen their secondary education program.

Armed with a Fulbright Grant for 1955-1956, she left the country in August on a team of three educational specialists who will work with the U. S. Educational Foundation in India, the Indian ministry of education and the Central Institute of Education, Delhi University, New Delhi.

Dr. Kelley, author of two books on education, is with the team as a consultant in the field of guidance and educational psychology. The group's first assignment was a series of conferences with Indian educators in New Delhi. Later the team will be consultants and lecturers at workshops in three locations in India. At these workshops the Americans will meet educators from state agencies in India, leaders of teacher training schools and superintendents of schools.

Dr. Kelley's important place in American education was recognized by Dickinson in 1954 when it conferred upon her an honorary doctorate on the occasion of the 30th anniversary of her graduation.

## Sudden Death Claims Professor Fink

**P**ROF. Cornelius Winfield Fink, chairman of the department of economics and the father of three Dickinsonians, died December 20 in the Carlisle Hospital two days after suffering a stroke. His wife, Mrs. Oneta Compher Fink, is the director of the College health center.

Prof. Fink came to the faculty in 1930 from a teaching position at Ohio University and was made head of his department in 1947. The debate coach at Dickinson for many years until 1952, he was very active in the Debating Association of Pennsylvania Colleges and was its president in 1944.

Born in 1893 near Zanesville, Ohio, he graduated from Muskingum College with an A.B. degree in 1914 and received an M.A. in 1924 from Ohio State University. He also did graduate work at the University of Michigan, the University of Wisconsin and Northwestern University.

He began his teaching career in 1920 at the high school in Dresden, Ohio, and became an instructor at Ohio State in 1922 and associate professor of economics at Ohio University, in Athens, in 1924, remaining at the latter institution until his call to Dickinson in 1930.

He contributed articles to the *Bulletin of the Debating Association of Pennsylvania Colleges* and the *Ohio Social Science Journal*. His organizations included the American Economics Association, the American Academy of Political and Social Science and Tau Kappa Alpha, honorary speech fraternity.

Prof. Fink loved the out-of-doors. He hunted big game in Maine and Canada and had a summer home in the Province of Quebec. Equally skilled with the casting rod and the high-powered rifle, he was active in sportsmen's groups wherever he lived.

Prof. Fink was a member of the Methodist Church and had been a Sunday School teacher for over 25 years. He belonged to Masonic bodies in

Athens, Ohio, and Carlisle.

He leaves, besides Mrs. Fink, a son, Esper, '40; two daughters, Mrs. Mildred Elizabeth Arnold, '41, Clearfield, Pa., and Mrs. Phyllis Eileen Baumgartner, '42, Kalamazoo, Mich., a brother, Ollie Fink, and a sister, Mrs. Hugh Mallett, both of Zanesville, Ohio.

Funeral services in Carlisle were conducted by the Rev. C. Gail Norris and Rev. Dr. Simpson B. Daugherty. The body was cremated.

### In Editorial Post

Carlyle R. Earp, '41, whose hobby is the study of history, has been invited to become an editor to assist in annotating *The Journal of Reverend Francis Asbury*. Dr. Elmer T. Clark, author and former editor of the *World Outlook*, is the Editor-in-Chief. Mr. Earp is now collaborating with Dr. Jacob S. Payton of Washington, D. C., in annotating the journeys of Bishop Asbury in Maryland and it is planned to complete the three volume work by the time of the Methodist General Conference next May.

## Engages In Ministry of Religious Song

**P**HILIP J. CARTWRIGHT, '42, who used to sing "for fun" as a boy soprano in the mission field in China and later as a member of the Dickinson College Choir, is now using his rich baritone-bass in a fulltime ministry of religious song.

Increasingly in demand by churches, schools and conference groups and by large resort hotels during religious seasons, Cartwright has three types of programs which he calls musical devotions, religious recitals and revival musical messages. The recent publishing of his record "The Life of Jesus in Song" has added to his reputation as a sympathetic interpreter of sacred music.

Born in a Methodist mission field in China, he started early in his singing career by appearing at the Community Church in Shanghai. While at Dickinson he received further experience in the College Choir and as a soloist in the Allison Methodist Church.

After college, Cartwright went to Honolulu where he engaged in the real estate and insurance business but found time to appear as soloist with the Honolulu Oratorio Society and the Honolulu Symphony Society. He played leads in operettas and sang in church choirs.

Ten years later he was back in Maplewood, N. J. The greater maturity and development of his voice impressed his friends, who urged him to devote his life to music. Cartwright began serious study with Frank LaForge and other noted teachers and his first religious concert was presented in Scranton, Pa., at a meeting of Methodist women of the Northeastern Jurisdiction. Response to that program brought about an invitation in 1952 to the General Conference of the Methodist Church in San Francisco, and a new career was securely launched.

Cartwright comes by his musical ability and religious zeal naturally. Mrs. C. H. Morris, the hymn writer and composer, was a progenitor. Dr. Frank T. Cartwright, a one-time missionary and

the senior member of the Board of Missions of the Methodist Church, is his father.

Rev. Lowell M. Atkinson, Ph.D., '32, pastor of the First Methodist Church of Englewood, N. J., has been named a contributing editor of the religious magazine *Pulpit Preaching*. Dr. Atkinson is vice-president of the Annual Conference Commission on World Service and Finance, and has recently been elected a trustee of the Methodist Home for the Aged, Ocean Grove, N. J. His present Church is considered one of the outstanding Churches of the Newark Annual Conference.

## Named Dean of Cornell University Graduate School

**P**ROF. JOHN W. McCONNELL, '29, was named dean of the Cornell Graduate School in November when announcement of the appointment was made by Dr. Deane W. Malott, president of the university. On the faculty of the School of Industrial and Labor Relations at Cornell since 1946, he succeeded Prof. S. S. Atwood, who became university provost.

An early portent of "Jack" McConnell's distinguished career occurred in his junior year at Dickinson College at the 1928 Commencement when he was the first to receive The Class of 1902 Award, which had been established at the 25th Reunion of that class in 1927.

For several years a research director in the Twentieth Century Fund, Prof. McConnell was co-author of the fund's book on "Economic Needs of Old People" and author of a chapter on "Social Welfare" in the new edition of its "America's Needs and Resources." His other works include "The Basic Teachings of the Great Economists," "The Evolution of Social Classes" and "A Guide to Community Study."

He has served on numerous arbitration and mediation groups and as a consultant on pensions and retirement policies to business and government agencies. He is now research counsel for the New York State Joint Legislative Committee on Unemployment Insurance and last October was consultant to the employment subcommittee of the Governor's Conference on Problems of the Aging.

At Cornell he is on the Committee on Student Conduct and the executive board of the Social Science Research Center and is chairman of an ad hoc committee on hospitalization and medical care for Cornell staff and faculty.

He has also served on the Graduate School's General Committee and its Scholarship and Fellowships Committee, as well as on the Fulbright Scholarship Board. He is vice president of the Cornell chapter of Phi Beta Kappa.

Born in Philadelphia on October 18, 1907, he graduated from the West Philadelphia High School and from Dickinson with Phi Beta Kappa honors in 1929. At Dickinson he became a member of Phi Kappa Sigma and Omicron Delta Kappa. He is a member of Phi Kappa Phi and numerous professional and educational societies.

Upon his graduation from Dickinson, Prof. McConnell taught at American University, Cairo, Egypt, 1929-32. He received his Ph.D. in 1937 at Yale, where he was Research Assistant in the Institute of Human Relations from 1933 to 1937. He was Assistant Professor of Economics and Sociology at American University, Washington, D. C., 1937-39, and Professor in the University College of Arts and Sciences at New York University 1939-46. He became a member of the Cornell faculty in 1946 and in 1953-54 was Fulbright Lecturer on Industrial Relations at Patna University in India.

He married Harriet Barlow in Philadelphia on July 29, 1933. They have four daughters and a son, aged 8 to 19, and live in Trumansburg, N. Y.

## Joins Staff As Assistant To President

**A**LBERT WALKER, a Midwesterner trained and experienced in educational public relations, became assistant to the president of the College on February 1.

He came to the campus after three and a half years at the University of Akron where he supervised the public relations program. He has been assistant to the president of Heidelberg College and director of public relations at Carthage College.

Walker also has a newspaper background, having been a reporter for the *Honolulu Star Bulletin*, in Hawaii, a *Stars and Stripes* overseas correspondent in World War II and an Army public information officer during the Korean conflict.

A native of Kansas City, Mo., he attended public schools there. He graduated from Baker University, in Kansas, and has a master's degree from Northwestern University. He majored in journalism at both institutions. At Baker, he was editor of the student newspaper and yearbook.

As the public relations director at Akron, Walker supervised the university's community activities, operated the news and speakers bureaus and handled promotional campaigns. He also edited university publications, the alumni magazine and president's newsletter and directed special campus events, including building dedication programs and an annual open house. At Akron, he also taught classes in journalism and was faculty adviser to the student newspaper.

President William W. Edel announced that Walker will supervise the public relations program, initiate and oversee special events and serve as a liaison officer between the college and the community. He will work closely with civic and church groups in College affairs.

He is 35 years old and is married to the former Mary Margaret Jones. They have a four-months-old daughter, Barbara Suzanne.

### Joins English Department

Walter R. Davis, graduate of Trinity College, in Connecticut, and holder of a master's degree from Yale, is the newest member of the Dickinson faculty. His appointment as an instructor in English was effective January 30 with the start of the spring semester.

Mr. Davis taught at the University of Rochester for the past two years. Before that he was an assistant in English at Yale, where he is a candidate for his Ph.D. He is a native of Middletown, Conn.

He graduated at Trinity in 1950 with honors in English and received a master's degree from Yale in 1951. He was a University Scholar at Yale in 1951 and 1953. While at Trinity he won the Tuttle Prize for excellence in English and contributed poetry to the literary magazine.

### Artist-In-Residence

A professional painter from Baltimore, Md., who is also an experienced art teacher, is the artist-in-residence at Dickinson for the spring semester. Joseph Sheppard, the artist, is a graduate of the Maryland Institute of Art who has had one-man shows in Baltimore and New York galleries and has exhibited in many national competitive shows.

A studio has been set up for him in East College and here he meets his classes in painting and design. He has three sections of Dickinson students in a two-credit course and teaches two adult evening classes.

The artist-in-residence is not a new experience at Dickinson. Miss Mary Snedeker, Philadelphia, the designer, spent the spring semester of the 1954-55 term at the College and Grant Rynard, the well-known painter, has visited the campus numerous times, his visits continuing from a day or two to a week.

## Appointed Judge of Supreme Bench of Baltimore

CORNELIUS P. MUNDY, '25L, who is better known to Dickinsonians as "Pat" Mundy, was appointed Judge of the Supreme Bench of Baltimore City last September by Governor Theodore R. McKeldin of Maryland.

In the presence of leading legal and judicial figures, he and Reuben Oppenheimer, who was also appointed, were inducted into office. The ceremonies marked the first time since 1922 that a new judge had been added to the Baltimore bench, despite the fact that during the past 33 years the city has nearly doubled in size.

"In making these appointments, Governor McKeldin rose above political pressures," an editor commented, adding "Both of these men have high reputations at the Bar. Both were the possessors of lucrative practices and will have to make continuing sacrifices to remain on the bench. Both yielded to the arguments of thoughtful citizens and put public duty ahead of personal gain."

That Pat has fulfilled the promise of his student days is evidenced by the fact that in his induction Chief Judge Emory H. Niles said that Mundy was "long and well known for his keen sense of humor."

He is frequently called upon for public speaking engagements and toastmastering. He is well known as a wit and humorist, both in speaking and writing. He is the author of humorous articles, published in the *Daily Record* and *Evening Sun*: "The Law of Houseboats," "How to Influence Judges and Win Cases," "Golf in the Middle Ages," "Courtroom Recollections," and "The Hospital Pest—The Patient."

Judge Mundy was born in Wilmington, Del., on September 3, 1900, and was educated at the Lawrenceville School, Yale University and the Dickinson School of Law, where he received his LL.B. degree in 1925. The next year he was admitted to the Maryland Bar. Four

years later he was appointed Assistant U. S. Attorney and in 1934 he was named a Special Attorney in the Department of Justice to be followed in 1935 by an appointment as Special Assistant to the Attorney General of the United States.

In 1935-1940, Judge Mundy was a Lecturer at the University of Baltimore Law School and in 1942-43 he was Chief Enforcement Attorney for the Office of Price Administration. At the time of his appointment to the bench he was serving as Chairman, State Tax Commission of Maryland to which he had been named in November 1954.

He has served on numerous committees of the Baltimore City Bar Association and Maryland Bar Association. In 1954 he was a member of the Maryland Court Reform Commission.

He was married to Elizabeth Wright Harrison on October 2, 1937. They have two children, Cornelius P. Mundy, Jr., aged 16, student at the Gilman School and Molly, aged 13, student at Garrison Forest. Their home is at 4712 Keswick Road.

## Small-Town Practitioner Chosen Top 1955 Doctor

**T**HE honor of "General Practitioner of the Year" was bestowed on Dr. E. Roger Samuel, '10, of Mt. Carmel, Pa. (pop. 15,000), by the American Medical Association at its annual session in Boston on November 29 when about 4,000 physicians attended the sessions. He also received a special award from the Medical Service Society of America, representing 10,000 pharmaceutical agents. The story was told in newspapers over the country and was reported in *Time* and other magazines.

It was the second time in his life Dr. Samuel was honored for what he had done. Shortly after his graduation from the University of Pennsylvania Medical School in 1913, he was wounded at Ypres, France, while serving as a captain in the Army Medical Corps assigned to the British forces and was awarded the Purple Heart Cross.

Dr. Samuel, 66 years old, has practiced in Mt. Carmel, his home town forty-two years. His father practiced there half a century. In accepting the award he said that he considered "the career of a family physician the most rewarding in all medical practice." He was also cited, however, for having "served diligently and enthusiastically in civic and religious groups covering a wide range of interest."

He was selected out of 50 nominees. His name had been presented by the Medical Society of Pennsylvania, of which he is a former president. He originally was sponsored by the Mt. Carmel Rotary Club and the Northumberland County Medical Society. Patients, colleagues, fraternal and civic groups and churches sent testimonials.

Through the years, Dr. Samuel has been actively interested in Dickinson affairs. He is a Life Member of the General Alumni Association and last June ended a three-year term as a member of the Alumni Council. He has been and

## Wins Acclaim As An Heraldic Artist

SINCE her election to the Heraldry Society of England nearly a year ago, the spotlight has focused on Learned James, the professional name of Mrs. Clifford R. James, the former Eugenia Learned, '39, heraldic artist of St. Louis, Mo. There were only six Americans in the society when she became a member.

Last October a two and a half column article telling of her work written by Mildred Weiler appeared in *The Christian Monitor* and another article by the same author appears in *The Optimist* magazine for January-February, 1956. The newspaper carried her picture and the magazine carries her picture and several illustrations. One of these shows a glazed china "Wars of the Roses" chess set, valued at \$1,500, in which each piece is authentically costumed with the proper coat of arms.

The idea of making a fancy chess set formed in her mind when at fifteen she saw a movie with her father which started her in what has become her profession. She is the daughter of Dr. Henry Dexter Learned, of the Temple University faculty, who taught German at Dickinson College one year when the late Dr. C. William Prettyman was on leave of absence.

In that movie, there was a scene where fancy chess pieces were used. Reaching home, she told her father she wanted to make a set and they agreed on the War of Roses theme. This led her to search for accurate descriptions of the armor worn by the knights as well as the authentic costumes for the kings, queens and bishops, and introduced her to the subject of heraldry which has absorbed her interests to this day.

For some time her work has been directed as a genealogist in establishing the right of Americans to use a family coat of arms and when that is proven, sometimes after many months of research and checking with the College of Arms in London, to provide them with the correct insignia.

While the "War of Roses" chess set stands in her studio, its walls are lined with china plates with reproductions of coats of arms in color, framed oil paintings of them, pictures of rings which she designed and posters. She also has an extensive library of heraldry and genealogy.

Her 15-year-old dream was slow in fulfillment because Eugenia was then a student in Lower Merion High School, Ardmore, Pa. When she graduated from Dickinson in 1939 she held a scholarship for a year's study in France, but World War II sent her into a publicity job. She did tourist publicity for the Department of Commerce of the Commonwealth of Pennsylvania for three years. Then in 1942-45 she was with the War Department, Internal Security Division at Harrisburg. In 1945, she married and moved to St. Louis.

A member of Pi Beta Phi and the Heraldry Society of London, she is also a member of the D.A.R., the Missouri Historical Society and the Collectors Society of St. Louis. She has written several articles on heraldry and history for publications of these societies.

Prime examples were the games with Penn State, Albright and F. and M. At the half, Dickinson was tied with the first two and led F. and M. by six points but lost to all three.

The season opened in road games with Lebanon Valley, 77-67, and Albright, 73-72. In the latter game, the team led by a point with six seconds to go when Mike DePaul sank a long one for the winners. Penn State was the first home opponent and the Lions sprinted in the late stages to win, 88-66. Elizabethtown, one of the better small-college teams, raced to an easy 104-73 victory in the Alumni Gymnasium. A few nights later the team lost a heartbreaker in Baltimore to Johns Hopkins, 70-68, but thrashed Western Maryland at Westminster, 89-62, in the last game before the Christmas recess.

James Connor, the junior, who set three new Dickinson individual scoring records last season, appears to be headed for another good record. After eight games his 19.3 average was tops for the team. Raymond Weaver, a fine sophomore guard, was next with 13.8 points,

followed by John Kohlmeier, the center, who had 10.5 and Don Leggett and Jack Wiley, the forwards, who had 9.3 each. These five have been the starters. Kohlmeier and Leggett are seniors, Connor a junior and Weaver and Wiley, sophomores.

**M**OST of the women who enter Dickinson College get married, and that's news; they bear children, and that's news; they die, and that's news. They are housewives, and that's not news.

Some get into unusual fields of endeavor or win fame through fine accomplishments, and when known their stories are told in THE DICKINSON ALUMNUS. But there is always a paucity of news about the fair co-eds.

While being a housewife may not be news to an editor, as already stated, a judge would decree it to be the greatest calling, an obstetrician would have no patients without it and a minister would proclaim it, at least on Mother's Day, as the greatest story ever told.

One of the many tasks of the Alumni Office is to try to keep up-to-date the biographical records of nearly 8,000 Dickinsonians, while also seeking information of everyone who has ever attended the college. In the mechanics of this work, a questionnaire was returned by a fair damsel of the Class of 1936. Her very clever response so well records the life of so many of the women of Dickinson that it should be told. It is a symbol of many "career women."

To *Other Colleges Attended* she answered: Now attending 3rd grade via son, John. Now attending 9th grade via daughter, Anne.

Filling *Literary Works* she wrote: Shopping Lists. Laundry Lists. Calendar Annotations — Doctor appointments, Dentist appointments. P. T. A. Meetings. Cub Scout Meetings. Girl Scout Meetings.

Then she read War Service—*Branch, Year Entered, year discharged and Rank*: To which she replied: *Branch*—Home. *Year entered* April 17, 1942 at Physician's Hospital, Jackson Heights, New York. *Year discharged* ??? *Rank* Varies—sometimes lower than P.F.C.—sometimes Six Star General. Scars many (all internal). *Awards*: Many, Many, Many.

And the answer to *Awards* crowns the story of the housewife. Mildred Chase Harvey can hear many, many, many Dickinsonians saying amen, amen and amen to that!

From 1913-1919, he taught in the high school at Wilkes-Barre, Pa., and then in 1919 became principal of the Carlisle High School serving until 1927, when he was named superintendent of schools. He continued in that office until 1946 when he was named area coordinator of the Pennsylvania area college centers. He was retired in 1954 when he was with the State Public School Building Authority.

A life long member of Allison Methodist Church, he was president of its Board of Trustees. He was also past president of the Carlisle Kiwanis Club, a past president of the South Central Pennsylvania Education Association, a member of the National Education Association and a member of the Tri-County Crippled Children's Association.

Surviving are his wife, Mrs. Iona Barber Potter, and two brothers, David Lee Potter, of Lewistown, Pa., and H. Stewart Potter, of Arlington, Va.

1914—Henry Rigdon, prominent tomato canner, cattle breeder and farmer of Harford County, Md., died on November 1, 1955 of a sudden heart attack at his ancestral home at Rocks, Md.

Born in the same residence on October 18, 1893, he lived his entire life on this ancestral farm, the deed of which dated back to a land grant from Leonard Calvert, First Royal Governor, 1634-47.

After being graduated from high school, he entered Dickinson College in 1910 and after two years there, he spent three years of study in engineering at Cornell University and was elected to Phi Beta Kappa honors in the spring of 1915, but left without being graduated in order to assume the management of the business enterprises of his father, who had just died.

Mr. Rigdon's interests were threefold. He operated a farm of 350 acres, and

he bred and raised Aberdeen Angus beef cattle on it. In 1923 he built his canning factory and he increased his canning business to a recent production of 20,000 cases of tomatoes. His quality brands bore the Premier and White Rose labels.

In the 1920's he attained considerable prominence as a producer of prize hybrid corn. He was awarded prizes in the states of Maryland, Pennsylvania and Delaware. Among the awards were three silver vases for being the Grand Champion of the Maryland Crop Improvement Association as well as Sweepstaker of the same award in the years of 1924, 1925 and 1928. He was the Grand Champion in the Corn Wold Class at the Pennsylvania State Products Shows of 1925 and 1927 and he won second and third corn prize awards at Chicago in 1921.

On April 26, 1919, he was married to Miss Margaret Lee Chapman, of Towson, Md. Three children, Frances Mary, George Benjamin and Henrietta, who died in infancy, were born to them. During World War II, his son, George, became his partner in business. He is married and has his home with his wife and son, Benjamin, at Rocks, Md.

Mr. Rigdon was small of stature but ambition led him to be vice-president and director of the Jarrettsville Truck Company, a trustee of the William Watters Methodist Church and an active member of the Historical Society of Harford County, Md., as well as a participant in many other business and civic interests. Mr. Rigdon attended Baltimore alumni activities and was a contributor to the Ten Year Development Plan.

The funeral service and interment were held in Harford County, Md., on November 3, 1955.

1915—The Rev. R. Watson Sadler, who had an unusual career in business and the ministry, died in a hospital in Bronxville, N. Y., on December 27, after suffering a heart attack. At the time of his death he was serving as pastor of the Union Congregational Church in Tuckahoe, N. Y.

A businessman for most of his life, Mr. Sadler turned to the ministry at the age of 54, when he entered Andover Newton Theological Seminary and received the B.D. degree there in 1950. While in business he was active in laymen's religious groups and studied theology. He was a member of SAE fraternity, the Pi Eta Club of Harvard, and National Federation of Men's Bible Classes.

Surviving are his widow, Mrs. Ellida Briedablik Sadler, and three daughters. Among his survivors are his brother, Rippey T. Sadler, '06, attorney of Brooklyn, N. Y.

1918L—Morgan J. Sheedy, prominent attorney of Altoona, Pa., died unexpectedly at his home on October 22. He had not been ill previously and had been at his office the day before his death.

Born in Altoona on September 25, 1896, he graduated from the high school there and the Law School in 1918. During World War I he served with the Navy and returned to the practice of law in Blair County in 1920.

For many years he was treasurer of the Blair County Bar Association and also treasurer of the Blair County Law Library. He was a member of St. Therese's

1927—Harold Kay died of a heart attack a year ago on February 12, 1955 in Harrisburg.

Born in Harrisburg on March 19, 1906, he graduated from Technical High School there and received his Ph.D. degree from the College in 1927. Some years after his graduation he attended the Harvard Graduate School and also the Wharton School of the University of Pennsylvania. He served four years with the Army in World War II. At Harrisburg he was engaged in hotel management and was the owner and operator of a motion picture theater. He was a member of Temple Ohev Sholom Synagogue and of the Elks.
