**H**OR THE second time in four years, Dickinson has been recognized for

giving.

The American Alumni Council announced in Washington that Dickinson was selected as the recipient of one of the Council's 1970 Alumni Giving Incentive Awards, winning first place for improvement among private coeducational colleges with an enrollment of more than 1,500 students.

superior performance in alumni

The award was presented to James N. Snyder '66, Dickinson's Secretary of Alumni Annual Giving, at the American Alumni Council's national conference in New Orleans. In addition to a cash award of \$1,000, the College received its second Mobius Strip, a mounted trophy which has become the symbol for distinguished achievement in the development of alumni support of universities, colleges and independent secondary schools.

Since 1959, the United States Steel Foundation has financed the Incentive Awards Program which is administered by the American Alumni Council. A distinguished panel of judges selects the winners from among those institutions entering a nation-wide competition. Emphasis is placed on the amount raised through Alumni Annual Giving. Evaluated also are the number of

contributors, the level of giving, the purpose for which the funds are raised, and evidence of deliberate efforts to sustain and improve alumni giving.

Dickinson's newest award is based on the College's 1969 campaign which found a record 3,971 alumni contributing nearly \$160,000, a 25 per cent increase over the previous year. Other donors—parents and friends of the College—raised the 1969 Dickinson Fund total to \$288,105 for another new Dickinson record.

The record of Dickinson's Annual Giving Program is an impressive story. During the past five years alone, alumni, parents and friends have contributed just under \$1,300,000 to meet current educational expenses not fully covered by tuition and endowment income. Annually, this has been equal to income from an additional \$5,000,000 in endowment funds.

The continuing concern we have at Dickinson is for people—the students and faculty who essentially make up the academic community. Annual Giving, to a great extent, reflects this concern. Perhaps that is why contributors have made a very definite point of keeping Dickinson's Annual Giving Program one of which we can be proud.









#### On Friday, September 4, 1970, while a great many Americans were preparing to set off for a long Labor Day Weekend, four hundred and fourteen young men and women were arriving in a small town called Carlisle, Pennsylvania—embarking on a journey of their own. These young people are Dickinson College's Class of 1974.

As has been the case for years, they generally arrived in the family car, accompanied by parents and a mountain of luggage. The majority were on the campus in time to attend an open house at the President's home that afternoon. Later in the day, most sat with their parents and heard the Dean of the College, Dr. Gerald S. Hawkins, describe in detail the College's academic program.

What followed was a freshman orientation program which was designed to accomplish a smooth integration of the new Dickinsonians into all aspects of the College community. It included lectures, panel discussions, tours of the physical plant with special emphasis on the use of the library, as well as meetings with student and faculty advisors. Several social events were held. Perhaps most important, the program, while varied, was also loose enough to leave time for just getting acquainted with classmates.

Assisting with the orientation were various orientation committees consisting of students and administrators, as well as student resident advisors, faculty advisors, the student personnel staff of the College and members of two honorary societies—Wheel and Chain and Omicron Delta Kappa.

On Wednesday evening, September 9, 1970, the Class of 1974, its 5 day orientation completed, formally took its place among the other members of the Dickinson family at Convocation exercises held in the Alumni Gymnasium. It was at this time that President Rubendall officially welcomed the class to the College community as he opened the College for its 198th year with a traditional pound of his gavel.

By design, the Class of 1974 is somewhat smaller in number than last year's freshman class, consisting of 189 women and 225 men. They were selected from a total of 1989 applicants and represent 24 states and the District of Columbia.

According to Robert A. Howard, Director of Admissions, the class is a strong one, both academically and in co-curricular interests. The following facts about the Class of 1974 would seem to bear this out:

- The average member of the class ranked in the top 17% of his secondary school graduating class. Over 65% ranked in the top 10%.
- The average SAT (Student Aptitude Test) verbal score was 607 for men and 632 for women. Average math scores were 639

for men and 615 for women. These scores are well above the national average.

- Over 30% of the women and 25% of the men received recognition from the National Merit Scholarship Program.
- Over 60% of the women and 50% of the men were honor students in their secondary schools (National Honor Society, etc.).
- The class has 112 men who lettered in secondary school athletics, 180 students who participated in musical organizations, 53 debators and 129 journalists.

As of this writing, 110 members of the class are receiving financial aid. This includes \$33,000 in loans, both from the College and the federal government; \$44,000 worth of state scholarships; \$91,000 in College scholarships; \$14,000 in federal grants; and scholarships totaling \$24,000 from outside sources.

Of special interest to alumni is the fact that over 10% of the class had close Dickinson ties.

According to Mr. Howard, "the Class of 1974 brings to the College a group of individuals, each of whom can add to the academic and cocurricular lives of their new environment. We wish each of them the success they are capable of attaining."







## "We're a Far Different School Now .... But Some Things Never Change"

In 1884, when Blaine and Cleveland were fighting it out on the hustings to see which of them would occupy the White House, and Bismark called together the colonizing heads of Europe to divide up Africa for its exploitable commodities, Dickinson College published its 102nd catalog.

The slim, fading volume came to hand some time ago when a curious professor, thinking about the College's 200th anniversary in 1973, began wondering what things were like the year Dickinson admitted its first co-ed.

He found that, in 1884, students paid an annual tuition of \$6.50. But most of them had scholarships. If a student was forced to borrow money, he read, he got it at three percent interest. "That's not exactly what he'd pay today," he sighed nostalgically.

A room for the year cost the student about \$12. His board, provided by a student-operated eating club or administration-approved boarding houses, ran him from \$2.50 to \$3.50 a week. He had to purchase his own furniture. In total, says the catalog, the least he could spend for his year at school was \$153. Luxury came a little higher—\$229 per year.

Enrollment figures in 1884 identified 93 four-year students, 21 of them from Carlisle. That year the College conferred 17 bachelors degrees. Ten students earned masters degrees.

Now shelving over 190,000 books and 1,160 periodicals, the Dickinson library then contained 8,393 volumes. With other collections maintained by the Belles Lettres and the Union Philosophical societies, the College's reading resources amounted to about 30,000 volumes. If you wanted a book, you waited until 11 A.M. on Saturday. That was when the library doors opened. The society libraries, on the other hand, were much more permissive. They accepted customers twice a week.

Being well before nuclear physics, electronic music and undifferentiated hair-do's, the Dickinson of 1884 expected most of its students to take the "classical" course. Its central ingredient was a four year dosage of Latin and Greek, although some theology students were permitted to substitute Hebrew in their junior and senior years. Classes were generally run on what a faculty quipster refers to as "the brokenrecord system. The kids read their assignments and turned up the next day to play back the contents."

The catalog felt that "the use of money is always a peril to the inexperienced" and consequently assigned each of its charges to a "patron" or advisor who passed out funds as needed. The amount of the tab was up to the "parents or guardians." There were certain exceptions, however. Under no circumstance was the patron allowed to disburse funds for "horse or carriage hire, confectionary, fruit, or other articles of mere luxury." Those were days of high purpose.

In 1884, the year France reenacted its divorce legislation, students were expected to behave themselves. Every month, patrons sent home "deportment" cards. Students who had achieved their "legal years," to repeat the catalog's chinup prose, were the only exceptions.

But incidents must have taken place reminiscent of modern timesfor the catalog, lowering its voice, admits that "for some the incitement and constraint of mere motives of reason are found to be inadequate." For such students, it grouses, "all resources of persuasion, supplemented even by such uses of authority as Colleges may make, are unavailing to secure either propriety of conduct or diligence in work." Translated, said a College interpreter, "that means some of the boys were raising cain and had to be shipped home." Or, as the catalog elegantly puts it, "withdrawn."

"We're a far different school now from what we were then," mused the curious professor. "But some things never change, I guess."



## Gobrecht's History of Dickinson Football is Ready for Publication

"After several futile attempts to arrange football matches, a fixture was made with Swarthmore College. Even then the chances for a game seemed rather poor, as it rained heavily the day before the one for the match; but the next day was clear and dry and Swarthmore's team appeared on time." Thus, the *Dickinsonian* began its description of what, according to Wilbur J. Gobrecht '52, was probably Dickinson College's first intercollegiate football game, played in Carlisle on November 14, 1885.

Gobrecht, associate professor and chairman of the Department of Physical Education and head football coach at Dickinson, has just completed the manuscript for his book, *Dickinson College Football History*, 1885–1970. Nowhere is there to be found such a complete account of one sport at the College.

The research for the work was begun by Gobrecht, with the assistance of former head coach Donald R. Seibert, in January of 1962. The finished product will contain an estimated 400 pages consisting of a complete narrative, available photographs of each Dickinson football team since 1885 and individual and team statistics.

According to Gobrecht, one of Dickinson's outstanding athletes in his own right, the book "traces the development of the sport of football at Dickinson from its meager beginnings to the present. The statistics have been compiled from newspapers, yearbooks and other school records. Background material was gleaned from many other sources, such as personal interviews and letters."

Apparently, the book points out, the previously mentioned game with Swarthmore in 1885 was not the first record of football at Dickinson. Morgan's history of the College suggests "the construction of a ball alley" as early as 1820. An early account of the game also appears in John Fletcher Hurst-A Biography, written by Albert Osborn, although the game described was undoubtedly more like soccer than football as we know it. In the book, Professor Charles F. Himes, a Dickinson faculty member and contemporary of Hurst, who was a member of the Class of 1854, presents the following account: "A game of football was held on campus in front of Old West. Football was in the fullest sense football, and a college game. It was a line-up along the broad path leading from Old West, of all students who wished to engage in the game in two well selected, evenly matched parties, and from the kickoff to the passage of the ball over either of the fences, constituting goals, it was kicked, never carried, and in the scrimmages many shins were kicked. The line-up was different each game, so that while some were recognized as most expert players, there were no match games to be recorded or even remembered. It was all sport and genuine sport . . . There were champion kickers . . . One, who kicked the ball over West College, died as a result of the effort."

From these beginnings, football at the College grew into what Coach Gobrecht calls the "Golden Years of Dickinson Football, 1896-1899." Under Dr. Nathan P. Stauffer, the College's first full time coach, the Red Devils compiled an enviable 25-15-3 record against imposing opposition the likes of the University of Pennsylvania, Penn State and Lafayette, all of which were nationally ranked teams of the period. The 1898 team, which was the best of this era and possibly "the best team in the entire history of football at the College," completed their season with an 8-2 record, losing only to the powerful Carlisle Indians and Penn State.

The remainder of the "pre-Modern" era of football at the College closed in 1911, after a series of rather mediocre seasons between 1900 and 1911. The period which Gobrecht refers to as the "Modern Era" began in 1912, when extensive rule changes made the game more like the game we know today. "Some of these rule changes were: four downs to make ten yards; reduction of the length of

the field from 110 yards to 100 yards, with end zones behind each goal; the legalizing of passes caught over the goal line in the end zone; the ending of the twenty yard limitation on the distance a forward pass could be thrown beyond the line of scrimmage; the moving of the ball from the middle of the field to the forty yard line for the kick-off; and the increasing of the value of the touchdown from five to six points."

The first team of the "Modern Era," the squad of 1912, while compiling only a 4-4-2 record, contained

two of Dickinson's Hall of Fame gridiron greats—Francis A. Dunn '14, and Hyman Goldstein '15. Dunn's incredible statistics for the season included more than 1,000 yards rushing and 1,300 yards total offense. His individual rushing record for one season has yet to be bettered. The 1917 team, which was coached by Dunn, compiled the first and only undefeated and untied season in Dickinson football history. The next similar season was to be twenty years later when the 1937 squad, led by Hall of Famer Samuel Padjen '39, compiled a 7-0-1 record. Only a 7-7 tie with Washington & Jefferson kept this team from giving Dickinson its second perfect season.

There have been many interesting and exciting moments in Dickinson's football history. There have been fine seasons other than those mentioned, such as the 1965 team's 7-1 record. There have also been some poor ones, such as the winless campaigns of 1915, 1930 and 1957. There have been some sad moments, such as the tragic death of Dickinson's E. Herbert Garrison during the Swarthmore game of 1886. And there have been many happy ones, such as the stunning upset victory over powerful Penn State in 1931. In his book, Gobrecht has tried to capture all of them-and some interesting sidelights as well.

## Boyd Lee Spahr Dead At 90

"The library stands today as a monument to Mr. Spahr's enduring interest in the College and respect for learning."

It is with sadness and regret that we report the passing of Boyd Lee Spahr '00, on Saturday, August 15, 1970. A central figure in Dickinson affairs for over 60 years, 'he died peacefully in his sleep in a hospital near his summer home in Manset, Maine. He had been a patient in the hospital for about a week.

Funeral services, which were attended by President Rubendall and other College officials, were held on Tuesday, August 18 at St. Christopher's Episcopal Church, Gladwyne, Pa., a short distance from Mr. Spahr's Haverford home.


Mr. Spahr was born in Mechanicsburg, Pa. in 1880. After graduating from Dickinson with Phi Beta Kappa honors in 1900, he studied law at the University of Pennsylvania. He became a widely-known corporation lawyer and member of the Philadelphia law firm of Ballard, Spahr, Andrews and Ingersoll.

As a leading member of the Board of Trustees for 62 years, it has been said that few major decisions relating to the College during that period were made without his participation. He served as Board President from 1930 until 1961, at which time he was named Honorary President of the Board and Life Trustee.

"Mr. Spahr's death is a serious loss to the College and marks the end of an epoch in our history," said President Rubendall. "No other person served Dickinson College with greater devotion and effectiveness over so long a period."

Over the years, Mr. Spahr held a special interest in the Dickinson library, giving it large sums of money from time to time and hundreds of valuable letters, books and documents relating to the nation's early history and to the formulative period of the College. In 1947, he established a lectureship in American History and, a few years later, also endowed a faculty chair in American History. Both bear his name, as does the \$2.3 million library building which was opened in 1967. It was said at the dedication of the Spahr Library that it would not have been built without Mr. Spahr's financial support and personal interest. "The library stands today as a monument to Mr. Spahr's enduring interest in the College and respect for learning," said President Rubendall.





Mr. Spahr's interests were broad. He was formerly national president of Phi Kappa Sigma fraternity and was also president of the Historical Society of Pennsylvania. He was an early President of the Dickinson Alumni Association and of the Dickinson chapter of Phi Beta Kappa.

An honorary degree was conferred on Dr. Spahr by the College in 1950, on the occasion of his 50th reunion. In 1965; he received the Gilbert Malcolm Alumni Award for "conspicuous service to the College over a long period of years." He was also the recipient of honorary degrees from Lafayette College and the University of Pennsylvania.

When Mr. Spahr received his honorary degree from the College, the citation read: "It is altogether probable that in the century and three-quarters since the founding of the College, no single individual has held so high an ideal of what the College ought to be and has given such a full measure of time, of wisdom and of material resources in order that his ideal might be achieved."

Mr. Spahr's intense interest in Dickinson continued to the end. His last visit to the campus was in May for the 70th reunion of his Class and the Commencement Meeting of the Board of Trustees.

Mr. Spahr's passing indeed "marks the end of an epoch in our history."
