BIOGRAPHICAL NOTE

Alexander A. Sharp was born in Newville, Pennsylvania, on January 10, 1862, to John Riddle and Martha Woods Sharp. Sometime during his early childhood, Alexander's family moved to Carlisle, Pennsylvania. He likely attended a local grammar school before advancing to the Dickinson Preparatory School in 1878. Finishing his preparatory studies, Alexander Sharp enrolled at Dickinson College where he graduated with a bachelor of arts degree in 1883. Active in both the Belles Lettres Society and Sigma Chi, Sharp maintained close connections with his old fraternity for the rest of his life.

Completing his studies at Dickinson, Alexander Sharp enrolled at the University of Pennsylvania to study medicine. It was during his time there that Sharp met his first wife, Jennie Beyard, whom he married on March 8, 1885. Receiving his medical degree in 1885, Sharp decided to forgo a life of medicine and moved out west to Larned, Kansas, working as a representative of the Mortgage Trust Company of Pennsylvania.

Taking an active interest in the civic affairs of Larned, Alexander Sharp held many prominent positions during his time in Kansas. These included positions not only among the local government, but also the local Masonic chapter. An active member of the National Guard, Sharp helped with the training of soldiers prior to World War I.

Alexander Sharp stayed in Kansas until 1921, when he moved to Chicago to head the corporation's regional offices. It was during Sharp's time in Chicago that he was awarded two honorary degrees from his undergraduate alma mater: a master's degree in 1926 and a doctor of laws degree in 1942.

During his life Alexander Sharp and wife Jennie Beyard had four children: Mary J. Woods Sharp, Richard Woods Sharp, John Beyard Sharp, and Elrich Cole Sharp. Sometime after the death of his first wife in 1934, Alexander Sharp married Lucille Deaton.

After bouts with prolonged illnesses, Alexander Sharp died on December 6, 1942. Having amassed a considerable fortune during his time in Larned and Chicago, Sharp decided to donate to the college that gave him his start. On February 5, 1938, the "Alexander A. Sharp Trust" was established which provided \$500 dollars a month to a student through the "Alexander A. Sharp Student Loan Endowment." Also established was a reading room in the Bosler Hall Library in 1941, which was transferred over to the Boyd Lee Spahr Library after its completion. This gesture of philanthropy would continue to influence his descendants as successive Sharp family members saw fit to donate both time and money to Dickinson College.

Not much at all is known about Alexander Sharp's sister, Mary J. W. Sharp (1863-1882). It is assumed that, like Alexander, she attended a local public grammar school.

COLLECTION DESCRIPTION

The Alexander Sharp Collection is housed in one document box and is divided into two series: Essays and Compositions and Miscellaneous. This collection was donated to the college by Mr. Charles G. Beetem.

The Essays and Compositions series includes writings from Alexander Sharp's grammar school and college years and from Mary Sharp's grammar school days. The essays, debate notes, and other school writings of Alexander and Mary are arranged chronologically for those materials that are dated, with undated writings following at the end. The essays cover a wide variety of topics and offer a glimpse of typical school work from the latter nineteenth century.

The Miscellaneous series contains materials regarding a William N. Sharp. There are two receipts reflecting William's guardianship for the heirs of Christian Geese, as well as an agreement regarding property that William Wilt was renting from William Sharp.
