ACTION OF THE SFJC

1. On January 13, two juniors were found guilty of plagiarism on term papers. Because there was resonable doubt as to intent SFJC recommended that they receive an F on their term paper.

2. On Jan. 16, a junior was found guilty of plagiarism on a term paper. Because there was reasonable doubt as to intent SFJC recommen-

ded that she receive an F on the term paper.

Also on Jan. 16, two male students were found guilty of being in sorority rooms after the legal hour. For this reason they were placed on disciplinary probation for the remainder of the academic year 1964-65. Disciplinary probation is here defined as maintaining exemplary conduct. A female, non-sorority student was found guilty of entertaining men in a sorority room after legal hours. For this reason she was denied the privilege of entering any sorority's rooms for any purposes whatsoever until the end of the present calendar year 1965.

Another female sorority member was found guilty of entertaining men in a sorority room after legal hours and permitting alcoholic beverages to be served in a sorbrity room. For these reasons she was denied the privilege of using any sorprity's rooms for any prupose escept to attend her own sorprity's chapter meetings and denied all sorprity social privileges until the end of the academic year 1964-65. Further she was placed on disciplinary probation until the end of the calendar year 1965. Disciplinary probation is here defined as maintaining exemplary conduct.

Also on Jan. 16, a freshman under 21 was found guilty of breaking the social rules relating to alcoholic beverages. For this reason he was suspended from Dickinson College for the first two weeks of the Spring Semester, placed on social probation until Spring Vacation and placed on disciplinary probation until the ond of the academic year 1964-65. Disciplinary probation is here defined as maintaining

exemplary conduct.

3. On Jan. 20, a junior was found guilty of plagiarism on a term paper. For this reason she was required to w ithdraw from the course

with a penalty grade of F.

Also on Jan. 20, a spphomore was found guilty of plagiarism on a term paper. For this reason he was required to withdraw from the course with a ponalty grade of F.

4. On Jan. 21, a froshman was found guilty of cheating on a final examination. For this reason he was required to withdraw from the

course with a penalty grado of F.

6. On Feb. 1, a junior was found guilty of conduct unbecoming a Dickinson College student for her improper behavior during a final exam. For this reason she was placed on disciplinary probation for the remainder of the present semester. Disciplinary probation is here defined as maintaining exemplary conduct.

- 7. On Feb. 2, a junior and a senior were found guilty of cheating on a final esam. For this reason they were dequired to withdraw from the course with a penalty grade of F. They were also found guilty of willful failure to give truthful testimony to the SFJC. For this reason they were suspended from Dickinson College for four class days and placed on disciplinary probation for the remainder of the present semoster. Disciplinary probation is here defined as maintaing exemplary conduct.

On feb. 4, a freshamn was found guilty of plagiarism on a term Because there was reasonable doubt as to intent it was recompaper. mended that she receive an F for the term paper and it was further recommended that she be required to write a non-credit term paper on antoher subject to be evaluated by her instructor in 2A before she receive a grade in the course.
