GAY LOBBY DAY UPDATE February 12, 1976

BACKGROUND AND ISSUES

RECRUITMENT (See Recruitment Letter)

As forms are returned to the Lobby Day Committee, each potential lobbyist will be sent another letter. They will be asked to verify their intentions of participating in Lobby Day. Directions and other pertinent information concerning the Work-

shops and Lobby Day Schedules will be included. In this letter, potential lobbyists will also be encouraged to engage in pre-Lobby Day activities, such as contacting their legislators ahead of time, or contacting the news media concerning gay issues.

EDUCATIONAL PACKETS

The Educational Packet, which will be distributed to the Legislators, is nearing completion. Funding for this project comes from GAA Philadelphia and the Quakers of Philadelphia. The packet will include the Greenberg Position Papers, an edited form of "25 Questions and Answers on Homosexuality", and lots of endorsements as previously established.

ACTUAL LOBBYING * LOBBY DAY, MARCH 23, 1976 !!!!!!!

It has been established that there will be a central gathering place for all lobbyists to meet the morning of March 23 for coffee, fellowship, and psyching. No platform will be available for anyone. We do not want speeches, etc. The Lobby Day Committee members will act as resource people. Probable location for this coffee hour is the Y.M.C.A. We will begin arriving at around 9:00 A.M. As lobbyists arrive, they will be instructed to call the telephone center at Harrisburg Gay Switchboard to report their arrival. There will be two phone lines available for use throughout the day. Statistical information, etc. will be available from the phone center. It will not be necessary for all lobbyists to wait around at the coffee center for late arrivals. After receiving necessary instructions, etc., lobbyists should get on with the business of actual lobbying. Resource people will be on hand for acouple of hourstto help late arrivals. A form will be used on which each lobbyist will amswer a few per inent questions as to the reactions of the Legislators who they saw. This info. will be tallied and kept available for future use.
