#### 1. Proclamation of Gay Pride Week

At a dinner honoring Governor Shapp, hosted by the Philadelphia Gay News (circulation 40,000), Dr. Ethel Allen announced Governor Thornburgh's proclamation of Gay Pride Week for June 15-24. Two days after issuance of the proclamation, the assembly voted 180-14 to ask the Governor to rescind the order. The Governor, of course declined to do so. A short discussion of the proclamation followed. Some Council members asked about Council participation in the issuance. The Chair mentioned that we were uninvolved. Other members asked about the appropriateness of the state action and it was agreed that in the future, perhaps, other more profitable ways could be found to channel the committment and interst of the Executive branch.

#### 2. PRIDE 79 Conference

The conference, the fourth in the last six years, will focus on issues of concern to the sexual minority community. Topics will include alcoholism and gays; problems of older lesbians and gay men; racism and the gay community etc. The conference is scheduled for the weekend of October 20, 1979 at the Holiday Inn at the Pittsburgh airport. In order to cut down on travel for Council members, the regular Council meeting in Pittsburgh is scheduled to coincide with the conference. Many organizations including the Council, the Pennsylvania Council of Churches, the ACLU, and unions and other groups are being invited to co-sponsor the conference.

#### 3. Alcoholism Update James Huggins

Two days of the ten day summer school offered by the Pennsylvania Council on Drug and Alcohol Use will be devoted to issues of Sexual Minorities. It is expected that training on similar issues will begin in the regions in the fall. We are awaiting other actions on our proposals.

#### 4. Report on Aging Ken George

(See attached for written report.) A discussion of Dr. George's report centered on the fact that sexuality among older people is an area often neglected by agencies servicing the group. In addition, homosexuals face problems different than heterosexual older people including the likely lack of support from family members and the stigma attached to homosexuality, to mention two problems. Problems in nursing homes are especially difficult. Leslie Phillips suggested wrking with the Episcopal church to develop programs and Walter Lear suggested tapping into the groups educating nursing home personnel. Ken noted that research has been confined to samples of white, middleclass men and so more work must be done to understand the problems of other groups.

The Council decided to continue its education in the area with a panal discussion at the State College meeting and to meet with the Secretary of Aging on the issue. The Fromin Center in Philadelphia received a 10,000.00 grant to study the problem and will work with

our Council on the issue.

#### 5. Announcements

The Council has been asked to co-sponsor the Pennsylvania meeting of the National Association of Social Workers.

### Issues for the Department of Justice: (Leslie Phillips, David Donaldson and Arthur Warner)

- 1. <u>Corrections</u>: Revising and strenghtening the training of Corrections officers, participation and support of the Prison Rape Conference and appointment of a representative to the Council from that Bureau.
- 2. Pennsylvania Constitutional Issues: The Pa. constitution must be examined to see if protections of privacy, association, speech and religion offer any possiblities for actions on gay related issues.
- 3. <u>Declaratory Judgement Act</u>: More information is needed on if the Attorney General can bring actions and if so in what court.
- 4. AG Opinion: More information is needed to know if an official opinion declaring deviant sexual intercourse as unconstitutional is a realistic objective of our Council.
- 5. Regulations: Since the AG's office reviews all state regulations, mechanisms should be explored to see that reviews include a look at compliance with the Governor's executive order.

Suggested Agenda Items for Meeting with the Secretary of Welfare (DR. LEAR)

- Regulations: Review of new regulations and amendment to a few key existing regulations.
- 2. Training of DPW Staff: County Assistance Officer, Youth Development Centers and available to Base Service Units.
- Financial Support of Mental Health Services: State Plan for MH services
   Needs Assessments and direct grants to Eromin and Persad.
- 4. Mental Retardation Services: Define problems, brainstorm solutions
