## GOVERNOR'S COUNCIL FOR SEXUAL MINORITIES

Harriaburg -- Tony Silvestre, chairperson of the Pa. Council fer Sexual Manorities, announced that resumes will be accepted from interested persons willing to serve on the council. After the first of the year, a mumber of council seats will be vacant because the terms of a number of members expire. Interested persons are requested to include the usual background data as well as information on their involvement in the area of sexual minority rights.

Prospective members must be willing to be identified as a member of a sexual minority and spend at least one full working day a month on council business. Travel expenses for members are paid by

the Governor's Office.

## Family Is 'Redefined'

Eligibility for a family membership used to mean that a couple had to be married. Not anymore, says the New York State Division of

Human Rights. Under the state's new Human Rights Law, gay couples, unmarried couples, and people living alone can now have family membership avail-

able to them. The New York State Human Rights Law prohibits discrimination on the basis of marital status in public accommodations, employment, housing and credit.

## SEXUALITY & LESBIANISM

Ginny Yaseen and Pam Keeley, Denver feminists, have been fighting a custody dispute. They face losing Rachele, six years old, Ginny's daughter who has been living with Pam and Ginny since 1972. Ginny's ex-husband is currently attempting to win permanment custody of Rachele.

At the time of the divorce, David, Ginny's ex-husband, was fully aware that Ginny and Pam were lovers. Ginny was awarded custody of Rachele in an uncontested divorce settlement. Ginny, Pam and Rachele then lived as a family in the same town in Illinois as David. In February of this year, Ginny, Pam and Rachele moved to benver. Following a visit by Rachele to her father this summer, during

which time David announced his intent to keep Rachele, and during which time Ginny had to fly to Illinois to reclaim her daughter, Ginny received a certified letter informing her that David had won tempory custody and that the formal hearing for final custody was scheduled one week hence. Without money, a lawyer, or time to prepare a case, Ginny flew to Illnois to protect her right to keep Rachele. She was held in contempt of court and jailed until it was proven that she had no knowledge of the tempory custody ruling at the time she had taken Rachele back home. She retained an Illinois attorney and succeeded in having the tempory custody ruling voided. But the struggle continues.

#### BUTCH OR FEM?

"Are you butch or fem?" A woman asked me that question four years ago and I still don't know the answer.

Four years ago I decided that it was time to meet some gay women. Before that time I always had the misfortune of falling in love with straight women. They would tell me that they loved me, but they had no intentions of going to bed with me. This was very frustrating and turned my nights into nights of solitary masturbation.

Meeting gay women was easy, but being accepted was a little harder. I didn't "come out" in Reading, so I will relate the difference between the two cities.

I came out in a college town. There the women weren't concerned about whether I was butch or fem. They did have a strange hang up about purses, though. That was my first lesson. Gay women don't carry purses. If I saw a woman that I wanted to be with; the proper thing to do was to buy her drinks, ask her to dance and then take her home to bed. Also preparing for a night out on the town, required wearing nice clothes and having finely combed hair.

Then I came to Reading. This is the town where I was asked if I was butch or fem. If "coming out" wasn't hard enough. Now I am told that I have to decide what I em. I went with a woman for four months and she never asked. Preparing for a night out on the town required less time. A pair of jeans and a sweat shirt or T-shirt was enough. It also helped if I could shoot pool or be awhiz at shuffle board. I was neither.

Meeting someone in this town was no easy task. There were so many cliques, that I just didn't seem to be accepted into any of them. I don't care about that now, because I have found a wonderful woman. I don't care about that bother's me is that I am considered a fem. I AM The only thing that bother's me is that I am considered a fem. I AM WOMAN. Gay, but I'm still a total, one-hundred percent woman. I have no need to stere-type myself after heterosexual relationships. I am a woman who loves a woman-not a butch or a fem.

The publishing house of Doubleday has announced that it will publish in the spring a book entitled By Her Own Admission, written by Guy Gibson of Dallas, Texas. The subject is the Mary Jo Risher child custody case, and Gibson's book deals honestly and sympathetically with the story of Mary Jo Rishers and Ann Foreman's fight to regain custody of Mary Jo's son Richard. Gibson is a close personal friend of Ann and Mary Jo's and has devoted months to assisting them in their legal struggle.

The California health department has ruled that homesexuals cannot be denied licences to operate homes for children solely because of their sexual preference. In a letter to district administrators who process license applications, a health official wrote, "What two consenting adults do in the privacy of their bedroom is a separate issue from how they relate to children. "
